Statement by the Executive Secretary of the Convention on Biological Diversity

At its sixth meeting in The Hague, April 2003, the Conference of the Parties to the Convention on Biological Diversity adopted the Global Strategy for Plant Conservation. The ultimate aim of the Strategy is to halt the current and continuing loss of plant diversity. The Strategy features 16 outcomeoriented targets, aimed at achieving a set of measurable goals by 2010. It is hoped that such targets, adopted by the international community, will provide a focus for concerted action by all actors, whether Governments, international organizations, civil society or the private sector.

The Strategy and its targets was developed in a two-year period through a unique partnership of international and national organizations, which continue to work together to facilitate and promote implementation of the Strategy. CITES has been a key player in this partnership and has provided inspiration, in particular, for Target 11: By 2010 "No species of wild flora endangered by international trade". I would like to pay tribute to the important role played by your Secretary, Professor Margarita Clemente, in contributing to the development of the Strategy in general, and of target 11 in particular.

We very much welcome the decision of the last meeting of the CITES Conference of the Parties to consider the targets of the Global Strategy for Plant Conservation and it is very positive that the Plant Committee is discussing the Strategy and analyzing the links between CITES and the CBD, at this meeting.

Target 11 was elaborated to be consistent with the CITES Strategic Plan, and we would welcome any further elaboration from the CITES community of how the Target can be successfully attained. A liaison group will meet in October 2003 to review progress on each of the targets in preparation for the ninth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA-9).

I see this as a very positive example of cooperation between biodiversity-related conventions on very tangible matters. I look forward to continuing close collaboration between our Conventions to address our common objectives and wish you all success in your important work.
