**2. National Legislation Project – Fiji ..... no document**

The Chairman noted that a request had been received from Fiji for an extension, from 31 December 2002 to 30 June 2003, of the deadline for it to enact legislation to implement CITES. As there was no documentation on this issue and no interpretation, it was agreed not to discuss the substance of the action undertaken by Fiji. It was noted that a recommendation to suspend trade with Fiji was already in place and would remain so until certain actions had been undertaken in relation to the control of the coral trade. It was agreed that, if these actions were implemented, and the recommendation to suspend trade consequently withdrawn, the Secretariat should take no further action to inform the Parties of a recommended suspension of trade with Fiji in the context of the National Legislation Project, pending discussion of this issue at the 49th meeting of the Committee. Representatives of Australia, China, Fiji and the United States of America participated in this discussion.

**3. Time and venue of next meeting ..... no document**

It was agreed that the Secretariat would try to organize the next meeting for April 2003 in Geneva and would inform the members as soon as possible. It was also agreed that, when announcing the meeting to all Parties, the Secretariat should also circulate a copy of the new Rules of Procedure of the Standing Committee.

**4. Any other business ..... no document**

The observer from Saudi Arabia, whose term as a member of the Committee had just ended, thanked the Parties of Asia for having had the opportunity to serve the region, sent best wishes to Ken Stansell who was currently ill, and wished the Committee every success during the forthcoming intersessional period.
