Interpretation and implementation of the Convention

NATIONAL LEGISLATION PROJECT

1. This document has been prepared by the Secretariat.

Legislative status chart

- 2. In response to a suggestion made during the 49th meeting of the Standing Committee (Geneva, April 2003), the Secretariat has prepared a chart showing the legislative status of Parties and dependent territories (see Annex).
- 3. Parties are invited to advise the Secretariat if they believe that there are any inaccuracies or omissions.

Parties with a deadline of 31 March 2003

- 4. The Secretariat is pleased to report to the Standing Committee that the legislation of Romania and the Russian Federation qualifies for category 1 status in the National Legislation Project.
- 5. Cameroon, Dominican Republic, Mozambique, Panama and South Africa have not yet enacted adequate legislation for implementation of the Convention but Cameroon and South Africa have provided information on their continuing progress.

Parties with a deadline of 31 December 2003

- 6. Pursuant to the instructions of the Standing Committee, the Secretariat issued formal cautions to a number of Parties, warning that they were in non-compliance with Decision 12.83. The communications included a sample CITES Legislation Plan and were sent directly to Management Authorities, with copies to permanent missions and regional representatives to the Standing Committee, on 9 July 2003. They advised affected Parties that if they failed to adopt adequate legislation by 31 December 2003, 'the Standing Committee shall recommend restrictions on commercial trade at its first meeting after that date unless a Party can show good cause for its lack of adequate progress'.
- 7. As shown in the Annex, many Parties have made adequate legislative progress (e.g. submitted a CITES Legislation Plan, developed draft legislation, submitted draft legislation to the relevant government legal office, submitted proposed legislation to Parliament, enacted legislation). A number of Parties, however, have advised that they require more time to complete the legislative process and have asked for an extension of the deadline by which adequate legislation should be enacted.

- 8. The following Parties have been in communication with the Secretariat but do not yet have adequate legislation and have not yet submitted a CITES Legislation Plan: Belize, Bolivia, Comoros, Djibouti, Eritrea, Grenada, Kazakhstan, Mauritius, Morocco, Philippines, Rwanda, Seychelles and Sierra Leone.
- 9. The following Parties have not yet provided to the Secretariat any information showing adequate legislative progress or good cause for the lack of adequate progress pursuant to Decision 12.83: Afghanistan, Algeria, Benin, Burkina Faso, Chad, Equatorial Guinea, Guinea-Bissau, Liberia, Malawi and Pakistan.

Parties and dependent territories with a deadline of 30 June 2004

- 10. Pursuant to the instructions of the Standing Committee, the Secretariat issued formal cautions to a number of Parties warning that they were in non-compliance with Decision 12.80. The communications included a sample CITES Legislation Plan and were sent directly to Management Authorities, with copies to permanent missions and regional representatives to the Standing Committee, on 9 July 2003. They advised affected Parties that if they failed to comply with their obligations under Decision 12.80 that 'the Standing Committee will take at its 50th meeting further action that may include restrictions on the commercial trade in specimens of CITES-listed species'.
- 11. As shown in the Annex, several Parties and dependent territories have made legislative progress.
- 12. Dominica has been in communication with the Secretariat but it does not yet have adequate legislation and has not yet submitted a CITES Legislation Plan. Mauritania, Saudi Arabia, Somalia and Uzbekistan have not provided any information.

Parties and dependent territories with no deadline

- 13. In previous reports, the legislation of Nigeria was erroneously listed in Category 1 when in fact it had been placed in Category 2. This has now been corrected in the legislative status chart. Nigeria has developed a CITES Legislation Plan which provides for the revision of draft legislation developed in 2002 and its adoption by 2005.
- 14. The legislation of Paraguay was placed in Category 1 as a result of the original legislative analysis. During the verification mission undertaken to Paraguay earlier this year, however, the Secretariat learned that significant portions of the country's legislation related to CITES have been abrogated and the legislation is no longer adequate for implementation of the Convention. The legislation, therefore, has been placed in Category 2. The enactment of adequate legislation is one of the main points contained in the action plan agreed between Paraguay and the Secretariat in October 2003.
- 15. New Parties to the Convention and a number of dependent territories, whose legislation is still being gathered and analysed, have not yet been given any deadline by which they should enact adequate legislation. In view of the large number of Parties that have been unable to meet their deadlines and that require assistance from and monitoring by the Secretariat, it does not seem practical at this time to establish a new set of legislative deadlines.

Recommendations

16. Parties with a deadline of 31 March 2003

The Secretariat proposes that the Standing Committee:

- a) Review the further legislative progress of Cameroon and South Africa at its 51st meeting; and
- b) Recommend a suspension of commercial trade in specimens of CITES-listed species with Dominican Republic, Mozambique and Panama.

17. Parties with a deadline of 31 December 2003

The Secretariat proposes that the Standing Committee:

- a) Review at its 51st meeting the further legislative progress of: Bahamas, Bangladesh, Barbados, Botswana, Brazil, Brunei Darussalam, Bulgaria, Burundi, Central African Republic, Chile, China, Congo, Côte d'Ivoire, Cyprus, Ecuador, El Salvador, Estonia, Gabon, Gambia, Ghana, Guinea, Honduras, Hungary, India, Indonesia, Israel, Jordan, Kenya, Madagascar, Malaysia, Mali, Monaco, Namibia, Nepal, Niger, Papua New Guinea, Peru, Saint Kitts and Nevis, Saint Lucia, Saint Vincent and the Grenadines, Sri Lanka, Sudan, Suriname, Togo, Trinidad and Tobago, Tunisia, Uganda, United Arab Emirates, United Republic of Tanzania, Uruguay, Venezuela and Zambia.
- b) Recommend restrictions on commercial trade in specimens of CITES-listed species with: Afghanistan, Algeria, Belize, Benin, Bolivia, Burkina Faso, Chad, Comoros, Djibouti, Equatorial Guinea, Eritrea, Grenada, Guinea-Bissau, Kazakhstan, Liberia, Malawi, Mauritius, Morocco, Pakistan, Philippines, Rwanda, Seychelles and Sierra Leone.
- c) Write to China, Madagascar, Malaysia and Peru, who have high volumes of international trade in specimens of CITES-listed species; urging them to give priority attention to the development of adequate legislation.

18. Parties with a deadline of 30 June 2004

The Secretariat recommends that the Standing Committee agree to:

- a) Review at its 51st meeting the further legislative progress of: Antigua and Barbuda, Belarus, Cambodia, Georgia, Latvia, Mongolia, Myanmar, Pitcairn Islands, Saint Helena and Dependencies, South Georgia and the South Sandwich Islands* and Swaziland.
- b) Consider appropriate measures, which may include restrictions on the commercial trade in specimens of CITES-listed species, for: Dominica, Mauritania, Saudi Arabia, Somalia and Uzbekistan.

19. Parties and dependent territories with no deadline

The Secretariat recommends that the Standing Committee:

- a) Establish a deadline by which Nigeria should enact adequate legislation.
- b) Establish a deadline by which Paraguay should submit a CITES Legislation Plan and a deadline by which it should enact adequate legislation.
- c) Instruct the Secretariat to address the issue of new Parties and dependent territories without any deadlines in its report to the 13th meeting of the Conference of the Parties on the National Legislation Project.
