RECOMMENDATIONS OF THE COMMITTEE

The Nomenclature Committee recommends:

Regarding the budget of the Nomenclature Committee

1. The adoption of the budget for the two subcommittees as proposed in paragraphs 18 and 34 of document Doc. 11.11.4.1:
 - a) Fauna subcommittee: USD 10,000 annually; and
 - b) Flora subcommittee: USD 27,000 annually.

Regarding amendments to Resolution Conf. 10.22 on Standard Nomenclature (cf. Document Doc. 10.39)

2. The adoption of the standard references as explained in document Doc. 11.11.4.1, and included in document Doc. 11.39.

Regarding annotations to and nomenclatural changes in the appendices

Fauna

3. Continuation of the use of the names of the wild populations of *Bos gaurus* and *Bos mutus* in the appendices, and annotate these to the effect that the domesticated forms (respectively *B. frontalis* and *B. grunniens*) are not subject to the provisions of the Convention
4. If the proposed standard for chameleons (cf. Document Doc. 11.39) is adopted, include in Appendix II the generic names *Calumma* spp. and *Furcifer* spp. for Chamaeleonidae spp., each with the same annotation as *Bradypodion* spp, and delete the annotation of *Chamaeleo* spp.
5. That Parties use the correct names for *Tupinambis* spp, as described below and in paragraph 14 of document Doc. 11.11.4.1, from 1 August 2000 onwards; and
6. To annotate *Tupinambis* spp. in the following manner:
 - = 4xx *Tupinambis merianae* (Duméril & Bibron, 1839) was until 1 August 2000 listed as *T. teguixin* (Linnaeus, 1758) (Distribution: Northern Argentina, Uruguay, Paraguay, southern Brazil, extending into southern Amazonian Brazil).
 - Tupinambis teguixin* (Linnaeus, 1758) was until 1 August 2000 listed as *Tupinambis nigropunctatus* (Spix, 1824) (Distribution: Colombia, Venezuela, Guianas, Amazonian basin of Ecuador, Peru, Bolivia and Brazil, in Brazil south into State of Sao Paulo.).

Regarding the nomenclature of *Brachypelma*

7. The replacement of Notification to the Parties 1999/29 by a new one, stating that:
 - a) *Brachypelma andrewi* is a synonym of *Euathlus truncatus* and therefore not included in the CITES appendices; and
 - b) *B. annitha* and *B. harmorii* are synonyms of *B. smithii*.

Regarding an amendment to Resolution Conf. 10.2

8. The inclusion in paragraph e) of Annex 1 to Resolution Conf. 10.2 after the words 'of the species' the following text:

(in accordance with the adopted standard nomenclature)
