# CONVENTION ON INTERNATIONAL TRADE IN ENDANGERED SPECIES OF WILD FAUNA AND FLORA

## Twelfth meeting of the Conference of the Parties Santiago (Chile), 3-15 November 2002

## Strategic and administrative matters

## **IDENTIFICATION MANUAL**

1. This document has been prepared by the Secretariat.

#### Introduction

- 2. At its 11th meeting, the Conference of the Parties adopted Resolution Conf. 11.19, transferring the responsibility of the publication of the Identification Manual to the Secretariat.
- 3. As required in Resolution Conf. 11.19, the Secretariat regularly reported to meetings of the Standing, Animals and Plant Committees.
- 4. This document is a summary of the reports concerned and provides an overview of the current status of the Identification Manual.
- 5. The Secretariat would like to draw attention to the fact that Parties, within one year of the adoption of a proposal to include new species in the Appendices, are exhorted to provide appropriate data for inclusion in the Identification Manual (see Resolution Conf. 11.19). See also paragraphs 7 and 28 below.

#### Identification Manual for Fauna

- 6. Since 1979, only 23 Parties have submitted draft data sheets. The main contributors have been Switzerland, followed by Germany and Canada, the United Kingdom of Great Britain and Northern Ireland, Australia, France and the Netherlands.

#### Future activities

- 30. Depending on available time, money and man power, priority will be given to include the Identification Manual on the CITES web site. In preparation for this, the Secretariat has contracted the former editor of the CITES Identification Manual, Dr J.-P. Biber, to convert all the published sheets into electronic format.
- 31. A first trial regarding the format for the inclusion of the Identification Manual on the CITES website has already been prepared for the Flora sheets, and will be available as soon as possible on site.
- 32. Finally, the Secretariat would like to commend the work carried out by Environment Canada which has created a series of identification guides designed specifically for individuals responsible for the application of CITES in various countries.
