The proposed amendments to Resolution Conf. 4.6 (Rev. CoP15) in Annex 1.2 of document CoP16 Doc. 25, as amended in summary record CoP16 Com. II Rec. 2 (Rev. 1), had been accepted by Committee II and were <u>adopted.</u>

Annex 2 Conf. 9.5 (Rev. CoP15) – Trade with States not party to the Convention

The proposed amendments to Resolution Conf. 9.25 (Rev. CoP15) in Annex 2 of document CoP16 Doc. 25 had been accepted by Committee II and were <u>adopted</u>.

Committee II had agreed to retain paragraph h) of the section under 'RESOLVES' of Resolution Conf. 11.1 (Rev. CoP15) and with this additional amendment, had accepted the proposed amendments to this Resolution in Annex 5.2 of document CoP16 Doc. 25, which was <u>adopted</u>.

Annex 6 Conf. 11.17 (Rev. CoP14) – National reports

This Annex had been withdrawn by the Secretariat as the revision of Resolution Conf. 11.17 was to be dealt with under agenda item 30. This was <u>noted</u>.

Annex 7 Conf. 11.18 – Trade in Appendix-II and -III species

The draft amendments to Resolution Conf. 11.18 in document CoP16 Com. II. 1, as amended in summary record CoP16 Com. II Rec. 5 had been agreed by Committee II and were <u>adopted</u>. The Committee had noted that, as a result, Resolution Conf. 11.18 would be defunct and it was clarified that paragraph f) under 'Recommends' in Resolution Conf. 10.3 would not be deleted. This was agreed.

The draft amendments to Resolution Conf. 12.3 (Rev. CoP15) in document CoP16 Com. II. 2 had been agreed by Committee II with amendments indicated in summary records CoP16 Com. II Rec. 5 and CoP16 Com. II Rec. 13 (Rev. 1), and were adopted.

Annex 9 <u>Conf. 12.10 (Rev. CoP15) – Registration of operations that breed Appendix-I animal species</u> for commercial purposes

This Annex had been withdrawn in Committee II owing to a lack of support. This was noted.

Annex 10 <u>Conf. 13.6 – Implementation of Article VII, paragraph 2, concerning 'pre-Convention'</u> <u>specimens</u>

The draft amendments to Resolution Conf. 13.6 in document CoP16 Com. II. 3 had been agreed by Committee II and were <u>adopted</u>.

Annex 11 Conf. 13.8 – Participation of observers at meetings of the Conference of the Parties

The draft amendments to Resolution Conf. 13.8 in Annex 11 of document CoP16 Doc. 25 had been accepted by Committee II and were adopted.

The draft revision of Resolution Conf. 10.10 (Rev. CoP15) in document CoP16 Com. II. 26, as amended in summary record CoP16 Com. II Rec. 13 (Rev. 1), has been agreed by Committee II and was <u>adopted</u>. Decisions 13.26 (Rev. CoP15), 14.76, 14.77, 14.79 (Rev. CoP15) and 15.74 were <u>deleted</u> and Decision 14.78 (Rev. CoP15) was <u>extended</u> to CoP17, as agreed by the Committee.

As agreed by Committee I, document CoP16 Doc. 27 (Rev. 1) was <u>noted</u>. Decisions 15.15, 15.16 and 15.17 were <u>deleted</u>, as agreed by the Committee.

Compliance and enforcement

28. National laws for implementation of the Convention

The draft decisions contained in document CoP16 Doc. 28, as amended in summary record CoP16 Com. II Rec. 14 (Rev. 1), had been agreed by Committee II and were <u>adopted</u>. Decisions 15.38 to 15.41 were <u>deleted</u>, as agreed by the Committee.

29. Enforcement matters

Committee II had accepted the draft revision of Resolution Conf. 11.3 (Rev. CoP15) in Annex 1 to document CoP16 Doc. 29 (Rev. 1), as amended in summary record CoP16 Com. II Rec. 10 (Rev. 1), and this was <u>adopted</u> as amended. The draft decisions in Annex 3 to the document, together with three draft decisions in summary record CoP16 Com. II Rec. 10 (Rev. 1) had also been agreed by the Committee and were <u>adopted</u>. Document CoP16 Doc. 29 (Rev. 1) was <u>noted</u>, as agreed by the Committee.

30. National reports

Committee II had accepted the proposed amendments to the Resolutions Conf. 4.6 (Rev. CoP15) and Resolution Conf. 11.17 (Rev. CoP14), and the proposed amendments to Decisions 14.39 (Rev. CoP15, 14.40 (Rev. CoP15) and 14.41 (Rev. CoP15) and the draft decisions in the Annexes to document CoP16 Doc. 30 (Rev. 1), except that all references to 30 June in Annex 2 would remain as 31 October. It had also agreed that Annex 5 of the document would be subject to further input from the Standing Committee's working group on special reporting requirements. This was <u>agreed</u> and the Conference of the Parties <u>adopted</u> the proposed amendments to the Resolutions and Decisions, as well as the draft decisions. Decisions 14.37 (Rev. CoP15), 14.38 (Rev. CoP15), 15.42 and 15.43 were <u>deleted</u>, as agreed by the Committee.

31. <u>Disposal of illegally-traded and confiscated specimens of Appendix-I, -II and -III species</u>

The draft decision in document CoP16 Com. II. 21 had been accepted by Committee II and was adopted.

Trade control and marking

32. Introduction from the sea

The draft decisions and draft amendments to Resolutions contained in the Annexes to document CoP16 Doc. 32 (Rev. 1) had been accepted by a vote in Committee II, with amendments indicated in summary record CoP16 Com. II Rec. 7 (Rev. 1). The final text of the amendments was shown in document CoP16 Com. II. 35. Argentina made the following statement, requesting that it be included in the record of the meeting:

Thank you very much, Mr Chairman,

Argentina would like to take the floor to bring to the plenary a concerning situation that took place in Committee II during the conversations related to the Introduction from the sea.

Argentina submitted an amendment to the draft resolution clarifying the scope of the resolution regarding chartering operations that should therefore have been subjected to a vote by the Chair of the Committee. Unfortunately, the amendment was dismissed with the observation that a regional group disagreed with it. Mr Chairman, as we duly noted, CITES has 178 Parties with the same right to vote.

This week, we have talked at length about the need to improve transparency in CITES; Mr Chairman, the transparency of decisions is not limited to the secret ballot. Ensuring that all Party States to CITES have the same opportunity to express their national position and to submit proposals and/or

amendments is as important as the issues discussed on the secret ballot because it ensures fairness and equal treatment for all States party to CITES.

The substance of the discussion refers to the role of Regional Fisheries Management Organizations. The intention of the resolution adopted without the Argentine amendment is to extend the regulations and requirements of RFMOs to all CITES Parties. This is unacceptable for Argentina. Any decision emanating from an RFMO is only binding for the member States of such RFMO, and under no circumstance or reason can it be compulsively extended to the rest of the international community.

We do not wish to take much of the precious time of the Conference of the Parties. Argentina came to this meeting in a profound spirit of flexibility and cooperation. We regret the way in which this matter has been dealt with and hope that it will not set a precedent for future meetings of the Conference of the Parties.

Argentina requests that the present statement be entirely and textually included in the final summary record of the meeting. We will happily provide a written copy of it.

Thank you very much, Mr Chairman.

Noting the intervention by Argentina, the amendments to Resolutions Conf. 12.3 (Rev. CoP15) and Conf. 14.6 (Rev. CoP15) and the draft decisions contained in document CoP16 Com. II. 35 were adopted.

The draft amendments to Resolution Conf. 12.3 (Rev. CoP15) in document CoP16 Com. II. 20, as amended in summary record CoP16 Com. II Rec. 12 (Rev. 1), had been agreed by Committee II and were adopted.

37. Proposal to amend Decision 14.77 on a Decision-making mechanism for a future trade in elephant ivory

Committee II had considered these two agenda items together and had agreed on a draft decision contained in document CoP16 Com. II. 18, which was <u>adopted</u>.

38. Purpose codes on CITES permits and certificates

Committee II had agreed that the subject should be referred back to the Standing Committee and agreed to amend Decision 14.54 (Rev. CoP15) to refer to the 66th meeting of the Standing Committee and the 17th meeting of the Conference of the Parties. The proposed amendment to Decision 14.54 (Rev. CoP15) was <u>adopted</u>.

39. Transport of live specimens

The draft revision to Resolution Conf. 10.21 (Rev. CoP14) presented in document CoP16 Doc. 39 (Rev. 1) had been agreed by Committee II and the revised text of the Resolution was presented in document CoP16 Com. II. 12. This proposed revision was <u>adopted</u> and the recommendations in the document were <u>accepted</u>. It was <u>agreed</u> that the Secretariat would make the necessary consequential amendments to Resolution Conf. 12.3 (Rev. CoP15), including those specified in summary record CoP16 Com. II Rec. 8 (Rev. 1). Decisions 15.59 and 15.60 were <u>deleted</u>, as agreed by the Committee.

40. Cross-border movement of musical instruments

The draft resolution and the draft amendments to Resolution Conf. 12.3 (Rev. CoP15) contained in document CoP16 Com. II. 25, as amended in summary record CoP16 Com. II Rec. 14 (Rev. 1), had been agreed by Committee II and were adopted.

The draft decisions in document CoP16 Com. II. 14 had been agreed by Committee II and were adopted.

The draft amendments to Resolution Conf. 13.7 (Rev. CoP14) in summary record CoP16 Com. I Rec. 13 (Rev. 1) had been accepted by Committee I and were <u>adopted</u>.

Document CoP16 Doc. 49 was <u>noted</u>, as agreed by the Committee. Decisions 15.44 and 15.45 were <u>deleted</u>, as agreed by the Committee.

50. Asian big cats

The draft revision of Resolution Conf. 12.5 (Rev. CoP15) in Annex 2 to document CoP16 Doc. 50 (Rev. 1) and the draft decisions document CoP16 Com. II. 30, as amended in summary record CoP16 Com. II Rec. 14 (Rev. 1), had been accepted by Committee II and were <u>adopted</u>. Decisions 15.46 to 15.49 were <u>deleted</u>, as agreed by the Committee.

51. Illegal trade in cheetahs

Committee II had accepted the draft decisions presented in document CoP16 Doc. 51 (Rev. 1) under paragraph D of the *Comments from the Secretariat*. It also noted the Secretariat's intention to filter sensitive information received on illegal trade so that not all would be passed to the consultant who would conduct the study. After Qatar and Ethiopia intervened to request clarification from the Secretariat about the role of the consultant, the draft decisions were adopted.

The draft resolution in document CoP16 Com. II. 17, as amended in summary record CoP16 Com. II Rec. 13 (Rev. 1), had been agreed by Committee II and was <u>adopted</u>.

Committee II had considered these two items together. The draft decisions in document CoP16 Com. II. 24, as amended in summary record CoP16 Com. II Rec. 13 (Rev. 1), and the additional draft decision in document Com. II. 34 had been agreed by the Committee and were adopted.

Committee II had considered these two items together and had agreed the draft decisions in document CoP16 Com. II. 23, as amended in summary record CoP16 Com. II Rec. 13 (Rev. 1).

Indonesia, supported by Malaysia and opposed by the United States, requested further amendments, and a vote was held as to whether the agenda item should be reopened. With 24 Parties voting in favour, 86 voting against and 21 abstentions, the item was not reopened (see Annex 1). Document CoP16 Com. II. 23 was <u>adopted</u>, as amended by Committee II. Decisions 15.79 to 15.83 were deleted, as agreed by the Committee.

59. Hawksbill Turtle

The draft decision in the Annex to document CoP16 Doc. 59 (Rev. 1) had been accepted by Committee II and was adopted. Decision 15.84 was deleted, as agreed by the Committee.

Committee II had considered these two items together and had considered a proposed revision of Resolution Conf. 12.7 (Rev. CoP14) contained in document CoP16 Inf. 53. With amendments indicated in summary record CoP16 Com. II Rec. 12 (Rev. 1), the revision had been accepted on a vote. The revised Resolution was <u>adopted</u>, as were the Secretariat's proposed draft decisions in document CoP16 Doc. 60.1 (Rev. 1).

61. Sharks and stingrays

The draft amendments to Resolution Conf. 12.6 and draft decisions in document CoP16 Com. I. 10 had been agreed by Committee I and were <u>adopted</u>.

Committee II had accepted the recommendations in paragraph 20 of document CoP16 Doc. 62 (Rev. 1) and the proposed draft decision, as amended by the Secretariat, and agreed that the Secretariat would recast the recommendations in paragraph 20 as decisions. This was <u>agreed</u>.

Document CoP16 Doc. 63 (Rev. 1) was noted, as agreed by Committee II.

Decision 14.100 (Rev. CoP15) was deleted, as agreed by Committee I.

The draft decisions in document CoP16 Com. I. 15 had been agreed by Committee I and were adopted.

66. Madagascar

Document CoP16 Doc. 66 (Rev. 1) was noted and Decision 15.97 deleted, as agreed by Committee I.

67.1 Report of the Plants Committee

One draft new and one draft revised Decision in the Annex to document CoP16 Doc. 67.1 (Rev. 2) had been accepted by Committee I and were adopted.

The draft resolution in the Annex to document CoP16 Doc. 67.2 (Rev. 1) and a draft decision, the text of which was in summary record CoP16 Com. I Rec. 4, had been accepted by Committee I and were <u>adopted</u>.

Draft amendments to Resolution Conf. 9.24 (Rev. CoP15) in document CoP16 Com. I. 6 had been agreed by Committee I and were <u>adopted</u>. Decision 15.51 was <u>deleted</u>, as agreed by Committee I.

Four definitions used in annotations and contained in documents CoP16 Doc. 75 (Rev. 1) and CoP16 Doc. 76 (Rev. 1) had been accepted by consensus in Committee II, where it was noted that they would be discussed by a working group of the Standing Committee, and these were <u>adopted</u>. Committee II had also agreed the draft decisions and the draft amendments to Resolutions Conf. 8.21 and Conf. 11.19 in the Annexes to document CoP16 Doc. 75 (Rev. 1), and the draft amendments to Resolutions Conf. 5.20, Conf. 9.24 (Rev. CoP15), Conf. 9.25 (Rev. CoP15) and Conf. 11.21 (Rev. CoP15) in document CoP16 Com. II. 27, and these were adopted.

77. Proposals to amend Appendices I and II

Two draft decisions on *Extinct or possibly extinct species* found in paragraph 12 of document CoP16 Doc. 77 had been accepted by Committee I and were <u>adopted</u>.

Having already been accepted by consensus in Committee I, the following proposals were <u>adopted</u> without discussion: CoP16 Prop. 1, Prop. 4, Prop. 5, Prop. 6, Prop. 7, Prop. 8, Prop. 9, Prop. 13, Prop. 14, Prop. 20, Prop. 21, Prop. 22, Prop. 26, Prop. 27, Prop. 29, Prop. 30, Prop. 31, Prop. 32, Prop. 36, Prop. 37 and Prop. 38.

The Chair of Committee I explained that some proposals had been accepted in that Committee in an amended form or with accompanying draft decisions: proposal CoP16 Prop. 2 (Rev. 2) had been accepted with the addition of the sentence "All other specimens shall be deemed to be specimens of species included in Appendix I and the trade in them shall be regulated accordingly" at the end of the annotation; proposal CoP16 Prop. 17 had been accepted with a draft amendment to Resolution Conf. 12.11 (Rev. CoP15) on Standard nomenclature incorporated into document CoP16 Com. I. 8; and proposal CoP16 Prop. 28 had been amended to retain the species concerned in Appendix II but with the annotation "zero export quota from the wild", which had been accepted together with two accompanying draft decisions in document CoP16 Com. I. 14. All of these were adopted without discussion.

The Chair of Committee I informed Parties that proposals CoP16 Prop. 33, Prop. 34 and Prop. 35 had not been submitted for decision in line with Rule 23.6 upon the adoption of CoP16 Prop. 32, and that proposals CoP16 Prop. 10, Prop. 11 and Prop. 12 had been withdrawn. This information was <u>noted</u>.

In agreement with the recommendations of Committee I, proposals CoP16 Prop. 3 (both the original and the amended version proposed during the Committee's sixth session), Prop. 15, Prop. 16, Prop. 18, Prop. 19, Prop. 23 and Prop. 24 were <u>rejected</u>.

The Chair of Committee I reported that proposal CoP16 Prop. 25, to transfer the Thai population of *Crocodylus siamensis* (Siamese crocodile) from Appendix I to Appendix II with a zero quota for wild specimens, had been rejected after a vote in Committee I. Thailand made a request to open debate on the proposal. This was supported by Cambodia, the Democratic Republic of the Congo, Ecuador and the Lao People's Democratic Republic. Ireland, on behalf of the Member States of the European Union and Croatia, reiterated that populations were fragmented and scattered, and opposed the opening of the debate. Switzerland too opposed a reopening of discussions.

The debate on proposal CoP16 Prop. 25 was opened after a vote with 48 in support, 74 objections and 16 abstentions (see Annex 2).

Thailand noted that current domestic legislation strictly prohibited harvesting of wild specimens and protected their habitats, believing that its re-stocking and rehabilitation programme contributed to the conservation of wild populations. It reported that surveys in protected areas had showed an increase in remnant populations, with the current numbers estimated at 200 individuals. It felt that, with the current captive-breeding programmes in place, it would reduce the incentive for any harvest of wild specimens and proposed the addition of three annotations to the proposal, to read as follows:

- 1. A zero export quota for wild specimens.
- 2. Thailand to provide a report of progress to the Secretariat.
- 3. Thailand offered third parties to oversee the implementation of their re-introduction programme.

Pakistan opined that the intent of the transfer to Appendix II was for the sustainable use of captive-bred specimens only and, together with Qatar, supported the amended proposal.

Ireland, on behalf of the Member States of the European Union and Croatia, believed that an Appendix-II listing would not prohibit trade in wild specimens and, together with Switzerland, did not support the amended proposal. Switzerland maintained its view that the species met the biological criteria for inclusion Appendix I. Seychelles requested that Thailand provide further information regarding the enforcement of the prohibition of trade in wild specimens.

Thailand believed that the current wild population size was such that the species did not meet the biological criteria for inclusion in Appendix I, and reiterated that domestic legislation protected wild populations, while strict management and enforcement prohibited trade. It emphasized that there would be no ranching for trade and that all traded specimens would be captive-bred.

Proposal CoP16 Prop. 25, with amendments, was <u>rejected</u> after a vote, with 57 in support, 70 against and 11 abstentions (see Annex 3).

The meeting was adjourned at 17h00.
