

# **MIKE Site Nomination**

### What is MIKE?

The Monitoring the Illegal Killing of Elephants (MIKE) Programme has been implemented by the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES), in collaboration with African elephant range States and with the support of the European Commission and other donors since 2001. The MIKE Programme aims to generate reliable and impartial data on the illegal killing of elephants and the status and trends in African elephant populations, in order to provide an objective basis for elephant conservation decision-making and action.

Since its inception, the MIKE Programme has supported ranger-based monitoring and the collection of information on elephant mortality in 58 sites across 30 African countries. Based on the information provided by these sites, MIKE has been at the forefront of documenting the alarming increases in levels of elephant poaching and has highlighted the urgent need for action to reduce the increasing threat to elephant populations across Africa as a result of the escalating international illegal trade in their ivory.

### What do MIKE sites do?

All MIKE sites are required to fulfil the requirements set out in the MIKE Site Monitoring Guidelines and Procedures document. Key MIKE site responsibilities are as follows:

- Nominating a site focal point with responsibility for overseeing MIKE-related activities at the site, as well as a national focal point if not already in place (Terms of Reference for both the site and national focal points can be found in the MIKE Site Monitoring Guidelines and Procedures document):
- Regularly collecting, synthesising and transmitting elephant mortality and patrol effort data according to the MIKE standardized formats and prescribed timeframes;
- Carrying out self-assessments of site law enforcement capacity, through completion of the MIKE Site-level Law Enforcement Capacity Assessment;
  - Facilitating independent verification of site data when requested by the MIKE SSU.

## What benefits do MIKE sites receive?

Due to limited funding which is already fully committed to existing MIKE sites, it is not possible to provide new MIKE sites with financial or material support. However, where feasible, the MIKE Programme will endeavour to provide new MIKE sites with access to training opportunities being provided to existing MIKE sites. In addition, all MIKE sites benefit from:

- Inclusion of MIKE site monitoring data in the analysis and regular CITES reporting on the implementation of the MIKE Programme across all participating range States;
- Acknowledgement of the MIKE sites' participation in and contributions to MIKE in MIKE Programme visibility activities;
- Representation at the range State level in the MIKE Programme regional steering committee and partners meetings.

#### How to nominate a MIKE site

The MIKE Programme encourages range States that have suitable conservation areas with elephant populations that are not already MIKE sites to nominate these areas for inclusion as new MIKE sites.

To do so, the wildlife management agency mandated for managing the proposed site should complete the attached application form electronically and email it to the relevant MIKE SSU (see contact details below). The application form must be accompanied by the following:

- A letter signed by the head of the management agency for the site being proposed, nominating the site and confirming the agency's willingness to meet the MIKE site requirements (A template for this letter is provided at the end of this Nomination Form);
- Geographical Information System (GIS) files of the proposed MIKE site showing the site's boundaries and other key features;
- A fully completed MIKE Site-level Law Enforcement Capacity Assessment (a copy of the self-assessment form can be obtained from the MIKE Subregional Support Unit).

Proposals for new MIKE sites will be reviewed by the MIKE Technical Advisory Group (TAG), and the concerned wildlife management agency will be informed in due course whether their application has been accepted.

MIKE also encourages NGOs supporting monitoring activities at potential new MIKE sites to work with their host wildlife management agencies in submitting application forms for their sites and, once accepted, in fulfilling the MIKE site monitoring data requirements according to the MIKE Site Monitoring Guidelines and Procedures. However, the MIKE Site Application Form is only to be submitted by representatives of the wildlife agency mandated for managing the proposed MIKE site (at the national or sub-national level as appropriate).
