Day 1 - Explanatory Notes:

Day 1 is about setting the scene, looking at CITES CoP and CBD COP processes including lessons learnt based on country delegates' own experiences from past CoP and COP meetings. CITES and CBD will each deliver presentations on their respective CoP and COP/COPMOP processes and highlight specific areas of differences.

Sharing experiences will help to engage participants in the discussions and bring out some useful information that could be addressed during the week. The "parking lot" approach will be used to park any important issue that might arise from the discussions for further discussion in the week.

Day 1 will also introduce the CoP / COP agenda for both CBD and CITES. In this session, an overview of the agenda for each of the CoP / COP will be provided, highlighting items where there might be of particular interests for the region. In introducing the agenda, the Secretariats will highlight items that they think would be useful to consider in the meeting. This will help guide the discussion on selection of items for the meeting to consider.

Once the meeting has identified key items for discussion, which could be up to eight items covering CITES and CBD, then the idea is to take two of those items at a time and zoom into the details of the selected items and review and discuss what the agenda item is about and what it is seeking in terms of decisions. The idea is to establish a clear understanding of the agenda items to enable participants to assess them in detail in the breakout groups.

The main task of the breakout group sessions is to assess the implications of the agenda items to Oceania-Pacific parties and propose preliminary suggested amendments to the text (for CITES agenda items) or inputs (for CBD agenda items), and possible positions for Oceania-Pacific. The groups could be divided into two main groups: CITES and CBD which could then be further divided into sub-groups depending on the items under discussion. For example, CITES issues could be discussed in one group given the small number of parties to CITES while CBD could be further divided into 2 or 3 sub-groups based on the complexity and scope of the item and issues under discussion. The CBD agenda item on marine is a classic example given that there are several sub-items included.

For each group, a chair (leader/presenter) and scriber should be selected from the parties. The Chair will report back in plenary on the outcomes of their group discussions.

Resource people will be assigned to each group (and sub-groups) to provide additional clarification and information.
