Species specific matters

Maintenance of the Appendices

87. Amendments to Resolution Conf. 9.24 (Rev. CoP17)

87.1 Proposed amendments to Resolution Conf. 9.24 (Rev. CoP17)

Namibia introduced document CoP19 Doc. 87.1 containing proposed amendments to Resolution Conf. 9.24 (Rev. CoP17) on *Criteria for amendment of Appendices I and II* to incorporate livelihoods and food security into the criteria for amending the Appendices. Namibia expanded that the purpose of this was to make people integral to the functioning of CITES, rather than side-lined.

Botswana, Cambodia, China, Cuba, Japan, the United Republic of Tanzania, and Zimbabwe supported the proposal, emphasizing that communities living alongside CITES-listed species should benefit from trade in them.

Burkina Faso, Canada, the European Union and its Member States, Gabon, India, Israel, Kenya, Liberia, Mali, Mauritania, Panama, Senegal, Togo, the United Kingdom of Great Britain and Northern Ireland, and the United States of America opposed the proposal, variously citing: the proposed amendments would alter the remit of CITES; addressing livelihoods issues was the main focus of other bodies; decisions on livelihoods and food security regarding listing proposals should be taken at national level; and CITES provisions, for example as in Section 10 of Annex 6 to Resolution Conf. 9.24 (Rev. CoP17) and Resolution Conf. 16.6 (Rev. CoP18) on *CITES and livelihoods*, already stipulated appropriate consultation in the preparation of amendment proposals. Several of these Parties, although opposing the document, stressed they believed implementation of CITES should involve consultation relevant to livelihoods and food security and were open to continued discussion of the means of minimizing negative impacts of proposals on livelihoods. The United States, echoed by Israel and Kenya, did not support such discussions taking place in the intersessional period. India urged Parties to restrain themselves from overuse of Article II 2 b) of the Convention text, whereby species were listed for 'look-alike' reasons, especially where livelihoods depended on these species.

China believed that more time should be devoted to this matter and proposed the following draft decisions:

Directed to the Animals Committee and Plants Committee

- **19.AA** The Animals Committee and Plants Committee, in collaboration with relevant organizations and experts, shall:
 - a) develop multi-disciplinary guidance materials that integrate livelihoods, food security and local knowledge into the relevant scientific decision-making framework of the Convention including, but not limited to, the criteria for amendment of Appendices I and II, Non-Detriment Findings, national quotas and Review of Significant Trade, and
 - b) report the outcomes of their work to the Standing Committee.

Directed to the Standing Committee

19.BB The Standing Committee shall review the outcomes of the implementation of Decision 19. AA and make recommendations to the 20th meeting of the Conference of the Parties to address the identified challenges with the aim of considering livelihoods and food security in the decision-making framework of CITES.

Japan noted it had not been consulted as a range State on a proposal to amend the Appendices at the current meeting and proposed the following text be added to the end of Section 10 in Annex 6 to Resolution Conf. 9.24 (Rev. CoP18): <u>'The Secretariat will not accept a proposal if the consultation information described above is not provided.</u>'

Citing Rule 23, paragraph 6, of the Rules of Procedure, Israel observed that the amendments to the document proposed by China and Japan should be decided upon by Parties before any decision on document CoP19 Doc. 87.1 in its original form. It also raised a procedural motion to close debate on the proposal under Rule 20.2 d). Panama spoke in favour of the motion; Botswana and Zimbabwe opposed it stressing the need for more time to debate this important matter.

The Chair proceeded to a vote on the procedural motion. With 58 in favour, 57 against and 12 abstentions, the motion to close the debate was <u>accepted</u>.

China and Japan noted the debate was closed and asked that their proposed amendments to document CoP19 Doc. 87.1 be included in the summary record for reopening the debate at the plenary. Noting a lack of consensus on the original proposal, the Chair moved to a vote. With 31 in favour, 86 against and 11 abstentions, the proposal to amend Resolution Conf. 9.24 (Rev. CoP18) in document CoP19 Doc. 87.1 was rejected.

Species specific matters

72. African lions (Panthera leo)

The Secretariat introduced document CoP19 Doc. 72 and its annexes, reporting on activities related to African lions as mandated by Decisions adopted at CoP18, including discussions with range States and relevant stakeholders for the implementation of initiatives on conservation of the species. Annex 1 contained revisions of Decisions 18.244, 18.247, 18.249 and 18.250 and a draft decision directed to the Standing Committee.

Congo, the European Union and its Member States, Ghana, Liberia, Mali, Niger, Nigeria, Senegal, Somalia, Togo, Uganda, the United Republic of Tanzania, the United States of America and Zimbabwe supported the draft decisions in Annex 1, noting that recent inventories across range States indicate continuing decline of African lions.

The United States, echoed by the European Union and its Member States and Humane Society International (HSI), opposed the deletion of Decision 18.246 proposed by the Secretariat, stating that it had not been implemented. To reflect this the United States proposed, with the support of Mali, Senegal, and Zimbabwe, the addition of a new draft decision:

Directed to the Secretariat

- **19.FF** The Secretariat shall:
 - a) share relevant information generated through the implementation of Decision 19.DD with the <u>CITES Big Cats Task Force, Standing Committee, or both, as appropriate; and</u>
 - b) report on the implementation of the previous Decision 18.246 to the 32nd meeting of the Animals Committee.

The Convention on Migratory Species (CMS) highlighted its cooperation with range States under the African Carnivore Initiative for the restoration of Central and West African populations of African lions.

The Committee <u>accepted</u> the draft decisions in Annex 1 to document CoP19 Doc. 72 with the new draft decision proposed by the United States of America and <u>agreed</u> to the deletion of Decisions 18.244, 18.246, 18.247, 18.249 and 18.250.

76. Saiga antelope (Saiga spp.)

The Chair of the Animals Committee introduced document CoP19 Doc. 76, drawing attention to the development of the 2020-2025 Medium-Term International Work Programme (MTIWP) for the saiga antelope in collaboration with the Convention on Migratory Species (CMS), and the review of stockpile management information received from Parties. Annex 1 contained proposed draft decisions. The Secretariat had proposed amendments to these under its comments.

Mali and the United States of America expressed their support for the draft decisions in Annex 1, the latter also noting its concerns with the amendments suggested by the Secretariat to draft decision 19.BB that limited mandates to requests by Parties. They also emphasized that any re-exports of saiga antelope from lawful stockpiles should be of specimens with evidence of lawful CITES trade prior to 2005 according to the zero export quota annotation agreed at CoP18.

CMS expressed their support to the draft decisions in Annex 1 and highlighted the implementation of international projects funded by the United States Fish and Wildlife Service under the CITES-CMS Joint Programme. Fauna and Flora International, also speaking on behalf of Environmental Investigation Agency and TRAFFIC, noted their concern with the omission of source, transit and consumer countries from paragraph b) of draft decision 19.AA pointing out that this would hamper effective implementation of the decisions.

The Committee <u>accepted</u> the draft decisions in Annex 1 to document CoP19 Doc.76 and <u>agreed</u> to delete Decisions 18.270 to 18.274.

58. West African vultures (Accipitridae spp.)

On behalf of the Standing Committee, the Secretariat introduced document CoP19 Doc. 58 containing, in Annex 1, new draft decisions on West African vultures (Accipitridae spp.) and a recommendation to delete Decisions 18.186 to 18.192. Under Comments of the Secretariat, alternative decisions had been proposed.

Benin, Burkina Faso, Burundi, the European Union and its Member States, Ghana, Mali, Niger, Nigeria, Senegal, the United States of America and HSI expressed support for the draft decisions in Annex 1, variously highlighting the ecological importance of vultures, the multitude of threats facing the taxon, and the need to regulate domestic and cross-border trade in West Africa. The United States indicated that it did not support the amendments to the draft decisions proposed by the Secretariat, apart from its correction to the name of the instrument in paragraph a) of draft decision 19.BB, in the table under Comments of the Secretariat.

CMS indicated its support for the draft decisions in document CoP19 Doc. 58 as amended by the Secretariat and drew attention to a 2021 report by the United Nations Environment Programme World Conservation Monitoring Centre (UNEP-WCMC) on *West African vultures: A review of trade and sentinel poisoning*.

The Committee <u>accepted</u> draft decisions 19.AA to 19.EE contained in Annex 1 to document CoP19 Doc. 58 with the amendment to paragraph a) of draft decision 19.BB made by the Secretariat in the document and the deletion of Decisions 18.186 to 18.192.

74. Songbird trade and conservation management (Passeriformes spp.)

The Chair of the Animals Committee introduced document CoP19 Doc. 74 with proposed revisions of Decisions 18.256 to 18.259 in Annex 1, noting that the main tasks under these Decisions could not be completed due to a lack of funding, but that partial funding had been received from the United States of America for a study of the songbird trade.

The European Union and its Member States, Malaysia, Mali, Singapore, the United States, BirdLife International and HSI supported the renewal of the decisions. The United States noted that the study under draft decision 18.256 (Rev. CoP19) would be focused on the western hemisphere. Malaysia, supported by HSI, emphasized the need for global assessments of the songbird trade and expressed its hope that the study could be extended to Asia. BirdLife International regarded songbirds as underrepresented in the Appendices despite their presence in legal and illegal trade, and offered its support over the next intersessional period. Mali requested capacity-building and training relating to songbird trade.

The Committee <u>accepted</u> the revision of Decisions 18.256 to 18.259 as presented in Annex 1 to document CoP19 Doc. 74.

60. Conservation of amphibians (Amphibia spp.)

The Chair of the Animals Committee introduced document CoP19 Doc. 60, Annex 1 to which contained draft decisions to extend Decisions 18.194 to 18.196, noting there had been insufficient resources to convene workshops as originally envisaged in Decision 18.194. Minor amendments to draft decisions 19.AA and 19.BB were proposed in the document under Comments of the Secretariat.

The draft decisions were supported by Argentina, Burundi, Colombia, Costa Rica, Eritrea, Guinea, Mali and Peru.

The Committee <u>accepted</u> draft decisions 19.AA to 19.CC in Annex 1 of CoP19 Doc. 60 and the deletion of Decisions 18.194 to 18.196.

The meeting was adjourned at 12h00.
