Strategic matters

25. Action plan on gender-related matters

Mexico introduced document CoP19 Com. II. 3 on behalf of the working group on the action plan on gender-related matters, noting that the document presented a draft resolution on *Gender and international trade in wild fauna and flora* and draft decisions relating to a gender action plan for CITES. It noted that although the working group had reached general agreement on the language, draft resolution and draft decisions presented in document CoP19 Com. II. 3, the group wished to recognise that one participant did not agree with the proposed language.

Indonesia, on behalf of Algeria, Bahrain, Egypt, Jordan, Kuwait, Oman, Saudi Arabia, Sudan, the Syrian Arab Republic, Tunisia, Türkiye, Qatar, the United Arab Emirates and Yemen, expressed concern about the draft resolution and decisions in the document, in particular its linkage to document CoP19 Doc. 25, which contains a definition of gender that many countries had not agreed upon. As a compromise, it proposed that a new paragraph containing the following text be added to the draft resolution in document CoP19 Com. II. 3: "Noting the definition of gender shall be defined in accordance with the laws, regulations, and concepts of each contracting Party". It also proposed the following text be added to a footnote in the title of the draft decisions in document CoP19 Com. II. 3: "Gender shall be defined in accordance with the laws, regulations and concepts of each contracting Party".

Botswana, Egypt, Mauritania, Somalia and Zimbabwe supported these suggested amendments. Egypt stated that it could not accept the definition of gender associated with the document. Mauritania noted that the definition of gender varies from country to country, and a broad definition would allow for the concepts of each country.

Argentina, the Plurinational State of Bolivia, Canada, Chile, Colombia, the European Union and its Member States, Niger, Panama, Senegal, the United States of America and World Wide Fund for Nature (WWF) supported the original text as presented in document CoP19 Com. II. 3.

Observing there was no consensus, the Chair proposed that Parties vote on the amendments presented by Indonesia. Bahrain requested a secret ballot. The request was supported by 14 Parties and therefore the vote took place through secret ballot.

The amendments presented by Indonesia on behalf of several other Parties were put to a vote by secret ballot. With 50 Parties voting yes, 51 voting no and 4 abstentions, the amendments were <u>not accepted</u>. The European Union and its Member States and the United States of America stated that they had voted against the proposed amendments.

The Chair then moved to a vote on the draft resolution and decisions in document CoP19 Com. II. 3. Bahrain asked that the second vote also be by secret ballot. The request was supported by 14 Parties and therefore the vote took place through secret ballot. With 73 Parties in favour, 29 against and 4 abstentions, the draft resolution and decisions contained in document CoP19 Com. II. 3 were <u>accepted</u>.

Argentina and Australia stated they had voted against the amendments presented by Indonesia and had voted in favour of document CoP19 Com. II. 3. The Plurinational State of Bolivia, Canada, Chile, Colombia, Ethiopia, the European Union and its Member States, Guatemala, Guinea, Guinea-Bissau, Japan, Liberia, Mexico, New Zealand, Norway, Switzerland, the United Kingdom of Great Britain and Northern Ireland and the United States of America stated that they had voted in favour of document CoP19 Com. II. 3.

Indonesia made a declaration that, for Indonesia, gender shall be defined in accordance with the laws, regulations and concepts of each contracting Party. Algeria, Bahrain, Comoros, Egypt, Jordan, Kuwait, Mauritania, Saudi Arabia, Tunisia, the United Arab Emirates and Zimbabwe made declarations that they aligned with Indonesia in this matter. Algeria and Kuwait also stated that they had voted against document CoP19 Com. II. 3 as presented to the Committee.

Maintenance of the Appendices

88. <u>Communications concerning amendments to the Appendices received by the Depositary Government</u> <u>after the 18th meeting of the Conference of the Parties</u>

Belgium introduced document CoP19 Com. II. 4, prepared by the drafting group on the basis of document CoP19 Doc. 88 and information document CoP19 Inf. 17 (Rev. 1), noting that the changes to the Resolutions as contained in document CoP19 Com. II. 4 had been agreed by consensus in the drafting group.

The European Union and its Member States, and Senegal, welcomed the document.

The Committee <u>agreed</u> to the amendments contained in document CoP19 Com. II. 4.

Interpretation and implementation matters

General compliance and enforcement

29. Compliance matters

29.2 Totoaba (Totoaba macdonaldi)

The United States of America introduced document CoP19 Com. II. 5, outlining their proposed amendments to the revised Decisions 18.292 to 18.295 and new draft decisions presented in Annex 2 to document CoP19 Doc. 29.2.1. The United States of America explained that they had collaborated with Mexico in the preparation of document CoP19 Com. II. 5, and that the proposed amendments were designed to strengthen surveillance and enforcement of the zero tolerance area, ensure timely reporting, address demand reduction, stress the urgency of the study on vaquita and totoaba, and encourage transit and destination countries to report on implementation.

Mexico stated that it would have liked to remove some parts of text which it saw as redundant, but in the spirit of compromise, agreed to submit the document as it stands. The European Union and its Member States, Israel, Senegal and Switzerland supported the document.

The Committee <u>agreed</u> the draft decisions in Annex 2 of CoP19 Doc. 29.2.1 with the amendments detailed in document CoP19 Com. II. 5 as proposed by the United States of America and Mexico. The

Secretariat noted that paragraph d) in draft revised Decision 18.292 (Rev. CoP19), should be amended to read:

d) provide financial and in-kind support for the implementation of the study called for in Decision 18.294, paragraph c) to be presented before the 7<u>7th</u>3rd meeting of the Standing Committee.

34. Annual illegal trade reports

The Secretariat introduced document CoP19 Doc. 34, drawing attention to the amendment to Resolution Conf. 11.17 (Rev. CoP18) on *National reports* contained in Annex 1, the draft decisions 19.AA and 19.BB contained in Annex 2, and the deletion of Decisions 18.75 and 18.76.

The European Union and its Member States supported the proposed amendment to the Resolution and deletion of Decisions 18.75 and 18.76 but noted that draft decision 19.AA concerned a long-standing action that is covered by Resolution Conf. 11.17 (Rev. CoP18) and should not be addressed in a decision.

China stated that it was important to acknowledge efforts of Parties related to national implementation so as not to damage the global image of the Party. Guinea stressed its need for support through the Compliance Assistance Programme.

The United Nations Office on Drugs and Crime provided further information on the data dissemination platform for the CITES Illegal Trade database. The Environmental Investigation Agency (UK), speaking also on behalf of a number of other observer organizations, supported the recommendations in the document but noted its concern that fewer than half of CITES Parties had submitted an annual illegal trade report.

The proposed amendment to Resolution Conf. 11.17 (Rev. CoP18) in Annex 1 to document CoP19 Doc. 34 was <u>agreed</u>. Draft decision 19.BB in Annex 2 was <u>agreed</u>; draft decision 19.AA was <u>not accepted</u>. It was <u>agreed</u> to delete Decisions 18.75 and 18.76.

35. Task Force on illegal trade in specimens of CITES-listed tree species

The Chair of the Standing Committee introduced document CoP19 Doc. 35 drawing attention to Decisions 18.79 and 18.80, proposed for deletion. The Secretariat drew attention to proposed draft decisions 19.AA to 19.CC under Comments of the Secretariat.

Brazil, the European Union and its Member States, India, and Singapore supported the draft decisions recommended by the Secretariat.

The United States of America proposed that paragraph b) of draft decision 19.BB be amended and include a new paragraph c) to read:

- b) subject to external funding, in cooperation with the UNODC / WCO Container Control Programme, work to undertake activities to provide training <u>by experienced CITES enforcement officials</u> on physical inspection of timber shipments in regions significantly affected by illegal trade in CITESlisted tree species, as well as to, where not yet done, encourage and support the undertaking of risk assessments to develop national risk indicators specific to this illegal trade.
- c) where not yet done, encourage and support the undertaking of risk assessments to develop national risk indicators specific to this illegal trade

The Committee note the document and <u>agreed</u> to the draft decisions in document CoP19 Doc. 35 as amended by the United States of America. It also <u>agreed</u> to delete Decisions 18.79 and 18.80.

38. Demand reduction to combat illegal trade

The Chair of the Standing Committee introduced document CoP19 Doc. 38, drawing attention to the amendments to Resolution Conf. 17.4 on *Demand reduction strategies to combat illegal trade in CITES-listed species* in Annex 1, proposed by the Standing Committee, and the draft decisions in Annex 2

The Plurinational State of Bolivia, Japan, Peru, Senegal, Thailand, the United States of America and TRAFFIC supported the draft decisions and amendments to the Resolution.

China opposed the recommendation by the Secretariat to delete the last paragraph of the preamble in Resolution Conf. 17.4. It proposed that the new draft decision 19.CC be deleted as it believed that the *Guidance* still requires some work. China also proposed amending paragraph 3 of the Resolution in Annex 1 to read:

ALSO URGES Parties to make full use of INVITES Parties to refer to the CITES guidance on demandreduction strategies to combat illegal trade in CITES-listed species in their efforts to reduce demand for illegally acquired wildlife and their products through the 5-step approach in order to achieve behaviour change of the consumers.and to share cases and experiences on how to achieve consumer behaviour change to enrich the guidance.

The European Union and its Member States supported the draft decisions and resolution as amended by the Secretariat and proposed an amendment to draft decision 19.AA e) as amended by the Secretariat to read:

Directed to the Secretariat

e) report to the Standing Committee on the progress made in the implementation of this Decision to the Standing Committee, and make recommendations on follow-up activities, including the identification of priority species and markets that may benefit from a demand reduction strategy and the use of the Guidance taking into account national and regional priorities.

Benin also supported the draft decisions and recommendations in the document but noted that the translation of the guidance document into local languages required significant funds. The Chair proposed amending draft decision 19.CC to read:

Directed to Parties

19.CC Parties are encouraged, <u>subject to available resources</u>, to translate the *Guidance on demand reduction strategies to combat illegal trade in CITES-listed species* into local languages and share their experience in the implementation of the *Guidance*.

The Committee <u>agreed</u> to the amendments to Resolution Conf. 17.4 as amended by the Secretariat but retaining the last paragraph of the preamble to the revised Resolution as proposed by China. The proposed amendment by China to paragraph 3 of the Resolution in Annex 1 was not agreed. The draft decisions as amended by the Secretariat, the European Union and its Member States and by the Chair were <u>agreed</u>. It was also <u>agreed</u> to delete Decisions 18.86 and 18.87.

Regulation of trade

45. Labelling system for trade in caviar

The Chair of the Standing Committee introduced document CoP19 Doc. 45 by drawing attention to the draft decisions in Annex 1 to the document, and the proposed deletion of Decision 18.146.

Supported by Georgia, the European Union and its Member States supported the deletion of Decision 18.146 and the proposed draft decisions, proposing an additional paragraph in draft decision 19.BB directed to the Standing Committee to read:

establish an intersessional working group that will examine the analyses and recommendations of the Secretariat once they are available and report to the Standing Committee;

The Committee <u>agreed</u> the draft decisions in Annex 1, with the European Union's amendment to draft decision 19.BB. The deletion of Decision 18.146 was also <u>agreed</u>.

41. Electronic systems and information technologies and authentication and control of permits

Switzerland introduced document CoP19 Doc. 41 on behalf of the Standing Committee. The document proposed amendments to Resolution Conf. 12.3 (Rev. CoP 18) on *Permits and certificates* in Annex 1, amendments to Resolution Conf. 11.3 (Rev. CoP18) on *Compliance and enforcement* in Annex 2, draft decisions Annexes 3 and 4 and the deletion of Decisions 18.125 to 18.128, 18.130 and 18.131.

The United Arab Emirates stated it had digitalised CITES permits and certificates and was ready to share its experience with other Parties. Australia, Benin, the European Union and its Member States, Niger and Peru supported the proposals in the document. Benin, the Democratic Republic of the Congo, Guinea, Kenya, Niger and Peru highlighted the need for sharing information and experience on the development and implementation of electronic systems. Kenya expressed concern with some proposed amendments to Resolution Conf. 12.3 (Rev. CoP18) and proposed the deletion of paragraph 3 t) ii). Kenya furthermore proposed an amendment to paragraph 3 d) to replace the word "adopt" with <u>consider adopting</u>, noting that not all parties were yet in a position put in place electronic permitting systems. It also expressed support for the draft decisions 19.AA, 19.BB and 19.CC in Annex 3.

The European Union and its Member States emphasized the importance of taking into account interoperability of CITES tools including the Electronic Permit Information eXchange (EPIX). The Democratic Republic of the Congo and the United States of America supported the recommendations in the document. The United States also supported the Secretariat's comments, with the exception of the Secretariat's proposed additional amendments, in paragraph C of their comments, to the instructions and explanations of the standard permit form and of the model travelling-exhibition certificate, which differed from the recommendations of the working group. The United States explained these additional edits from the Secretariat would be problematic in the case of partially completed permits, noting that if partially completed permits are used by a Party, then a place for a signature is required pursuant to Resolution Conf. 12.3 (Rev. CoP18), paragraph 22. B) iii) C. The United States also drew the Committee's attention to information document CoP19 Inf. 18 and proposed adding an additional paragraph to draft decision 19.BB in Annex 4 directed to the Standing Committee to read as follows:

consider ways in which electronic CITES permitting systems can simplify procedures for the noncommercial movement of musical instruments

The meeting was adjourned at 17h00.
