#### Regulation of trade

#### 51. Quotas for leopard (Panthera pardus) hunting trophies

The draft amendments to Resolution Conf. 10.14 (Rev. CoP16) *Quotas for leopard hunting trophies and skins for personal use* in paragraph 7 of document CoP19 Doc 51 as accepted in Committee I were <u>adopted</u>. Three draft decisions in the Comments of the Secretariat in document CoP19 Doc 51 with amendments recorded in summary record CoP19 Com. I Rec.16 as accepted in Committee I were <u>adopted</u>. Decisions 18.165, 18.167, 18.169 a) and 18.170 were deleted.

## 52. <u>Transport of live specimens: improving implementation of the transport regulations</u>

The amendments to Resolution Conf. 10.21 (Rev. CoP16) *Transport of live specimens* with amendments recorded in summary record CoP19 Com. II Rec. 13 as accepted in Committee II were <u>adopted</u>. Draft decisions in document CoP19 Doc. 52 as amended in summary record CoP19 Com. II Rec. 13 also accepted by Committee II were <u>adopted</u>.

#### Exemptions and special trade provisions

#### 53. Review of CITES provisions related to trade in specimens of animals and plants not of wild source

Amendments to Resolution Conf. 10.16 (Rev.) *Specimens of animal species bred in captivity* and the draft decisions in CoP19 Doc. 53 with amendments in summary record CoP19 Com. II Rec. 15 as accepted in Committee II were <u>adopted</u>. Decisions 18.172 and 18.173 were <u>deleted</u>.

# 54. Review of the provisions of Resolution Conf. 17.7 on Review of trade in animal specimens reported as produced in captivity

The Chair of Committee I noted that the original text of paragraph 1 of revised Resolution Conf. 17.7, *Review of trade in animal specimens reported as produced in captivity* contained in Annex 1 of document CoP19 Doc. 54, should be retained without brackets or strikethrough. The deletion of the paragraph had been in question (as recorded in document CoP19 Com. I Rec. 2) pending the conclusion of discussions by the Budget Committee, which has now taken place, no core funding being allocated for this work.

China indicated that its intention in amending paragraph b) of Resolution Conf. 17.7 had been to insert justified with supporting documented evidence after "Parties" so that the agreed paragraph would read

"The Secretariat shall also compile any other relevant information made available to it with respect to concerns about captive production, including any cases referred to it by Parties justified with supporting documented evidence or identified from the Review of Significant Trade under Resolution Conf. 12.8 (Rev. CoP18) on Review of Significant Trade in specimens of Appendix-II species, or available in relevant reports, including the global conservation status by species published in the IUCN Red List of threatened species or noted as not evaluated;"

The draft amendments to Resolution Conf. 17.7 (Rev. CoP18) Review of trade in animal specimens reported as produced in captivity in Annex 1 to document CoP19 Doc. 54 as amended in summary record Com. I Rec. 2 (Rev. 1) and by the Chair of Committee I and China were <u>adopted</u>. The three draft decisions in Annex 2 to document CoP19 Doc. 54 as accepted by Committee I were also <u>adopted</u>. Decisions 18.176 and 18.177 were <u>deleted</u>.

## 55. Registration of operations that breed Appendix I animal species in captivity for commercial purposes

A draft decision as recorded in summary record CoP19 Com. II Rec. 13 as accepted by Committee II was adopted.

The draft decisions in Annex 2 on *Trade in mammoth ivory* with the amendments proposed by the Secretariat and the draft decisions contained in Annex 4 on *Stocks and stockpiles (elephant ivory)* as accepted in Committee II were adopted. The draft decisions in Annex 3 amended in summary record CoP19 Com. II Rec. 6 (Rev. 1) as accepted by Committee II were adopted. Decisions 18.120, 18.121, 18.227, 18.182 and 18.183 were deleted.

### 66.2 Ivory stockpiles

66.2.1 <u>Ivory stockpiles: implementation of Resolution Conf. 10.10 (Rev. CoP18) on *Trade in elephant* <u>specimens.</u></u>

The draft decisions in document CoP19 Doc. 66.2.1 with amendments in summary record CoP19 Com. II Rec. 8 (Rev. 1) as accepted by Committee II were adopted.

66.2.2 <u>Establishing a fund accessible to range States upon non-commercial disposal of ivory stockpiles</u>

The draft decisions in CoP19 Com. II. 9 with amendments as recorded in summary record CoP19 Com. II Rec. 16 had not been agreed in Committee II. The recommendation from Committee II was accepted.

Kenya requested the following statement be included in the summary record:

Kenya is a major elephant range State, hosting the fourth largest savanna elephant population globally. Kenya developed the concept of establishing a fund accessible to range States upon non-commercial disposal of elephant stockpiles, in consultation with 30 other African range States. The intention is to develop an innovative way of mobilizing much needed resources to support sustainable conservation, including ensuring humanelephant coexistence, managing impacts of climate, and addressing human-elephant conflict, by disposing of our accumulating stockpiles, which are expensive and difficult to manage and secure. We had believed that CoP19 would approve starting the process of wider consultation, establishing an intersessional working group as a platform for negotiations. From the feedback, it is very clear that all range States require sustainable financial resources to support conservation of elephants and other species in a sustainable way. We have noted that the concept and the process towards realizing an innovative sustainable financing mechanism for wildlife conservation, that we proposed in document CoP19 Doc. 66.2.2 may not have been well-understood by a number of the range States, as evidenced by the outcome of the vote taken in Committee II. We therefore propose taking this idea forward with willing African and Asian range States and donors but outside of CITES first. Kenya will continue to engage bilaterally with willing range States and potential donors with a view to examining options for a funding mechanism and actualizing the objectives proposed in document CoP19 Doc. 66.2.2.

66.3 Implementing aspects of Resolution Conf. 10.10 (Rev. CoP18) on the closure of domestic ivory markets

Burkina Faso asked to open the debate on the draft decisions in document CoP19 Doc. 66.3. Mali supported opening the debate; Japan and Zimbabwe opposed. A vote was held. With 28 Parties in favour, 40 against and 57 abstentions the debate was opened.

Burkina Faso proposed adding two additional draft decisions to the document as follows:

#### Directed to the Secretariat

**19.EE** The Secretariat shall report on progress made with respect to the analysis in Decision 19.DD to the 77th meeting of the Standing Committee (SC77).

### Directed to the Standing Committee:

**19.FF** The Standing Committee shall consider the Secretariat's report under Decision 19.EE and request the Secretariat to take appropriate measures, if any.

Benin, Niger, Senegal and Togo supported the proposed new draft decisions. Botswana, Japan, Thailand and Zambia opposed it. Thailand supported the amendment proposed by Burkina Faso.

The Secretariat reminded Parties that paragraph 12 of Res. Conf. 10.10 (Rev. CoP18) *Trade in elephant specimens* already mandates the Secretariat to report on ETIS matters at each meeting of the Standing Committee and at each Conference of the Parties.

There being no consensus, Burkina Faso asked for a vote. With 69 Parties in favour, 27 against and 34 abstentions, the additional draft decisions 19.EE and 19.FF were adopted. The draft decision recorded in summary record CoP19 Com. II Rec. 6 (Rev. 1), as accepted in Committee II, was adopted.

The draft decision on a CITES Dialogue meeting in Annex 1 to document CoP19 Doc. 66.4.2 as amended in summary record CoP19 Com. II Rec. 8 (Rev. 1) and the draft decision on the export of live wild-caught African elephants as accepted by Committee II were adopted.

Botswana, on behalf of 16 Southern African Development Community (SADC) Member States, asked for the following to be included in the summary record:

We would like to remind Parties present here today, that trade restrictions cannot be imposed on Parties through adoptions of Decisions and Resolutions. Especially when the affected Parties are not in agreement with the recommendations made. We therefore urge Parties to work on consensus on matters that have direct implications on other Parties and allow for the unhindered implementation of the existing listings and annotations. SADC Parties commit to trade in all CITES listed species within the confines of the text of the convention as we have done in the past and going forward.

We remain open to engage through a Dialogue Meeting so that the concerns of the range States of the African elephant, of which SADC Member States hold the majority are addressed.

Senegal urged Parties to move forward in a spirit of consensus.

As the inclusion of this genus in Appendix II had been agreed by the Committee, the standard nomenclatural reference "Plants of the World Online" for this genus, as accepted by Committee I, was <u>adopted</u>.

#### 8. Language strategy for the Convention

Kuwait, speaking also on behalf of Algeria, Bahrain, Comoros, Egypt, Jordan, Mauritania, Morocco, Oman, Qatar, Saudi Arabia, Somalia, Syria, Tunisia, the United Arab Emirates and Yemen, introduced document CoP19 Plen. 1 on *Language strategy for the Convention*, prepared by Kuwait at the request of Committee II on the basis of document CoP19 Doc. 8 after discussion in Committee II.

Burkina Faso, Chile, the Democratic Republic of the Congo, Egypt, the European Union and its Member States, Liechtenstein, Mali, Niger, Russian Federation, Senegal, Togo and the United States of America supported the proposal, many emphasizing how incorporation of the three additional languages of Arabic.

Chinese and Russian would benefit the Convention, facilitate its implementation and allow more experts to be involved.

Chile proposed amending draft decision 19.BB Directed to the Standing Committee by replacing 'external funding' with extra budgetary contributions.

The new draft decisions presented in document CoP19 Plen. 1 as amended by Chile were adopted.

### 87.1 Proposed amendments to Resolution Conf. 9.24 (Rev. CoP17)

The Chair of Committee I reported that the proposed amendments to Resolution Conf. 9.24 (Rev. CoP17) on *Criteria for amendment of Appendices I and II* in document CoP19 Doc. 87.1 had been rejected by Committee I after a vote with 31 Parties in favour, 86 against and 11 abstentions. The proposed amendments to the Resolution were rejected.

China clarified that the draft decision it had proposed in relation to document CoP19 Doc. 87.1 had neither been withdrawn nor had been accepted by Committee I. The recommendations of Committee I were accepted.

87.2 <u>Aquatic species listed in the CITES Appendices – proposals for a new approach to the listing of sharks</u> and rays

Three draft Decisions found in document CoP19 Com. I. 7 as accepted by Committee I were adopted.

The amendments to Resolution Conf. 11.21 (Rev. CoP18) on *Use of annotations in Appendices I and II*; Resolution Conf. 4.6 (Rev. CoP18) on *Submission of draft resolutions, draft decisions and other documents for meetings of the Conference of the Parties* and Resolution Conf. 4.25 (Rev. CoP18) on *Reservations*, as contained in document CoP19 Com. II. 4, as accepted by Committee II, were adopted.

## **Proposals to amend the Appendices**

#### 89. Proposals to amend Appendices I and II

The Chair of Committee I reported that **proposal CoP19 Prop. 1 (Rev. 1)** amended to retain listing in Appendix II for *Hippopotamus amphibius* (Hippopotamus) with the following annotation: "A zero export quota for wild specimens traded for commercial purposes." had been rejected by Committee I after a vote with 56 Parties in favour, 56 against and 13 abstentions. Togo, supported by Niger, asked to open the debate. Botswana, supported by the United Republic of Tanzania, opposed this. With a vote of 44 in favour, 37 against and 48 abstentions, the debate was opened.

Togo, supported by Benin (also speaking on behalf of other co-proponents of the proposal), Congo, the Central African Republic, Mali, and Mauritania, noted that hippopotamus populations in West Africa were in decline and commercial trade, in particular illegal trade, in the species from any range State could potentially have negative effects on the species as a whole owing to pressures from demand and laundering of specimens.

The European Union and its Member States, echoed by the Democratic Republic of the Congo and South Africa, reiterated their opposition to the proposal. The European Union and its Member States stated that imposing a zero quota on all range States may risk undermining sustainable management of *H. amphibius* in those countries with large populations, where trade in parts and products, as well as legal hunting, forms part of the species conservation. Instead, the European Union and its Member States suggested a set of decisions inviting all hippopotamus range States to establish annual national export quotas set at sustainable levels to ensure sustainability of trade and to reduce the potential risk of illegal ivory trade among range States. This suggestion was not supported by co-proponents.

With a vote of 53 in favour, 58 against and 21 abstentions, proposal CoP19 Prop. 1 (Rev.1) was rejected.

The Chair of Committee I reported that the amended **proposal CoP19 Prop. 2** to transfer the population of *Ceratotherium simum* (White rhinoceros) in Namibia from Appendix I to Appendix II with the following annotation: "For the exclusive purpose of allowing international trade in live animals for *in-situ* conservation only and only within the species' natural and historical range in Africa" had been accepted in Committee I. The Chair of Committee I proposed an amendment to the annotation to read: "For the exclusive purpose of allowing international trade in live animals for *in-situ* conservation only and only within the species's natural and historical range of *Ceratotherium simum* in Africa", in order to avoid confusion regarding the definition of "species" under Article I of the Convention and to correctly reflect the spirit of the discussion in Committee I.

Proposal CoP19 Prop. 2 as amended was adopted.

The Chair of Committee I reported that amended **proposal CoP19 Prop. 3** to remove the existing annotation on the Appendix II listing of Eswatini's population of *Ceratotherium simum* (White rhinoceros) was rejected in Committee I after a vote with 15 in favour, 85 against and 26 abstentions.

Amended proposal CoP19 Prop. 3 was rejected.

The Chair of Committee I reported that **proposal CoP19 Prop. 4** to amend Annotation #2 pertaining to the populations of *Loxodonta africana* (African elephant) in Botswana, Namibia, South Africa and Zimbabwe, had been <u>rejected</u> in Committee I after a vote with 15 in favour, 83 against and 17 abstentions.

Zimbabwe, supported by South Africa, made a motion to open the debate on proposal CoP19 Prop. 4. Mali, supported by another Party, opposed this motion. With a vote of 31 in favour, 55 against and 47 abstentions, the debate was opened.

The meeting was adjourned at 17h00.
