For ease of reference, and similar to meeting agendas of the Plants Committee, the Decisions in Annex 2 are grouped under: Administrative and financial matters; Strategic matters; Illegal trade and enforcement; Regulation of trade; Species conservation and trade; and Appendices of the Convention.
- 4. The Chair of the Plants Committee asked all Members and alternate Members of the Committee to review the above-mentioned instructions and consider how they each could contribute to achieving their effective implementation. The Plants Committee then identified a lead or co-leads for each of the instructions as part of its workplan for 2023-2025, as shown in Annexes 1 and 2 to this document.
- 5. The Secretariat published Notification to the Parties No. <u>2023/044</u> on 5 April 2023 to inform the Parties that Mr. Ruben Boles of Canada will replace Ms. Cecilia Lougheed as representative for the North American region on the Plants Committee.
