Plants Committee strategic planning for 2023-2025 (CoP19-CoP20)

IMPLEMENTATION OF THE WORKPLAN FOR 2023-2025

1. This document has been submitted by the Chair of the Plants Committee.*
2. At its 26th meeting (PC26; Geneva, June 2023), the Plants Committee noted PC26 Doc. 8.1 and its two Annexes on Resolutions and Decisions in effect directed to the Plants Committee that require action from the Plants Committee or may need consultation with or assistance from the Animals Committee. The document also includes the overview of mandates directed to the Plants Committee with reporting requirements to the Standing Committee.
3. The Plants Committee last reported on progress in the implementation of its current workplan to the Standing Committee at its 77th meeting (SC77; Geneva, November 2023) in document [SC77 Doc. 6](#), which the Standing Committee noted.
4. The present document serves as a reference point on the progress achieved since SC77 and next steps for each of the Resolutions (Annex 1) and Decisions (Annex 2) of the Plants Committee's current workplan, with emphasis on relevant agenda items or working documents of the present meeting, and in the case of joint mandates, of the 33rd meeting of the Animals Committee (AC33).
