# CONVENTION ON INTERNATIONAL TRADE IN ENDANGERED SPECIES OF WILD FAUNA AND FLORA

# Strategic matters

#### CITES GENDER ACTION PLAN

- 1. This document has been prepared jointly by the Secretariat and the Chair of the Standing Committee.
- 2. At its 19th meeting (CoP19; Panama City, 2022), the Conference of the Parties adopted Resolution Conf. 19.3 on Gender and international trade in wild fauna and flora.
- 3. The Conference of the Parties also adopted Decisions 19.51 to 19.53 on CITES Gender Action Plan as follows:

# Directed to the Secretariat and Chair of the Standing Committee

- 19.51 The Secretariat and the Chair of the Standing Committee, subject to available resources, shall draw on the available body of knowledge, lessons and experiences on gender and how it interacts with other identifying factors in matters related to legal and illegal international trade of wild flora and fauna, to develop a draft gender action plan for submission to the Standing Committee. The draft gender action plan should:
  - a) consider the needs of indigenous and local peoples of all genders, especially women and girls, as well as how to incorporate their perspectives, skills and talents at all ages, and local and traditional knowledge:
  - b) aim to ensure that women and girls in all their diversity have equal access to, ownership and/or control over the use of wild flora and fauna, can fully and effectively engage in international trade of species of wild fauna and flora, and receive a fair and equitable share of benefits arising from the use and trade of such wildlife; thus reducing poverty and gender gaps through the promotion of economic and decision-making freedom;
  - c) aim to prevent and respond to gender-based violence in wild flora and fauna international trade chains;
  - d) promote gender equality and increase and strengthen the participation and leadership of women at all levels of decision-making and participation in processes related to international wild flora and fauna trade:
  - e) enhance the full, equal and meaningful participation and leadership of all genders, in particular women, in the implementation of the Convention, including through the engagement of civil society organizations, women's groups and women delegates, and provide opportunities for building their capacities; and
  - f) identify specific actions to advance the objectives above, across international trade chains for sustainable and legal wild flora and fauna, including parts and derivatives, as well as associated activities, including harvesting, law enforcement, and policy-making.

#### Directed to the Standing Committee

19.52 The Standing Committee shall consider any draft gender action plan received from the Secretariat under Decision 19.51 and, if considered appropriate, submit a final version of that action plan, as an annex to the Resolution on Gender and international trade in wild fauna and flora, for approval by the Conference of the Parties at its 20th meeting.

#### Directed to Parties and relevant stakeholders

- 19.53 Parties and relevant stakeholders, are encouraged to:
  - a) support the preparation of the "CITES Gender Action Plan" by sharing knowledge, case studies and other relevant experiences with the Secretariat;
  - b) strengthen the evidence base and understanding of the gender-differentiated impacts of sustainable use and international trade in species of wild flora and fauna, and fair and equitable benefit-sharing; and
  - c) provide financial support towards the development and implementation of the Gender Action Plan.

#### Update on the implementation of Decisions 19.51 to 19.53

- 4. The Secretariat issued Notification to the Parties No. 2023/130 of 24 November 2023, inviting comments on a number of SC77 documents and agenda items, including on the CITES Gender Action Plan. Previously, Notification to the Parties No. 2023/104 was issued on 23 August 2023 to invite Parties and other stakeholders to provide detailed information on knowledge, case studies, and other relevant experiences that may support the development of the CITES Gender Action Plan. A total of eleven inputs were received in response to the two notifications from the North America region, China, the European Union, Germany, Japan, Mexico, Sweden, the United States of America, Women4Biodiversity and the World Wide Fund for Nature. The overview of their inputs is summarized in Annex 1 to the present document. The responses to Notification to Parties No. 2023/104 will be used as resource for the development of the CITES Gender Action Plan.
- 5. The draft outline of the CITES Gender Action Plan was revised on the basis of the responses to Notification to Parties No. 2023/104. Further adjustments were made where necessary to ensure that the wording of the text is aligned with Resolution Conf. 19.3 and Decisions 19.51 to 19.53 and takes into account the discussions at CoP19. The revised draft outline is found in Annex 2 to the present document. For ease of reference, the full text of the inputs received by the Secretariat can be found in an information document to the present meeting.
- 6. The Secretariat has highlighted in grey in Annex 2 five proposed edits that the Standing Committee may wish to consider further due to their substantive nature:
  - a) The North America region proposed to include a reference to demand reduction efforts so that these efforts become gender-aware and gender-responsive.
  - b) The North America region also proposed to add "enforcement and engagement" so that representation and participation of all genders be enhanced in the implementation, enforcement and engagement of the Convention. Previously the text only mentioned the "implementation of the Convention".
  - c) Mexico proposed to include the concept of "cultural relevance" in two sections of the outline. There is currently no reference to cultural relevance in the text of the resolution or the three decisions.
  - d) Mexico also proposed to be more specific in the "relevant organizations" referred to under the objectives, to include "women's and indigenous peoples' organizations that promote indigenous women's participation".
  - e) The North America region proposed to add "particularly women and girls as transmitters of knowledge, with their free, prior and informed consent", when referring to the incorporation of the perspective and knowledge of indigenous peoples and local communities as one of the strategies and interventions.

- 7. As a preparatory step for the CITES Gender Action Plan, the Secretariat collected information from other Multilateral Environmental Agreements, as well as the United Nations Environment Programme (UNEP), regarding their gender policy, action plans, or equivalent, which is summarized in Annex 3 to the present document.
- 8. As noted in document SC77 Doc. 26, the Secretariat has received funds from the European Union towards the partial implementation of Decision 19.51, but no other donors came forward to co-finance the full implementation. The Secretariat was therefore unable to develop the draft gender action plan due to lack of financial and human resources for this new workstream. The Secretariat invites the Standing Committee to consider maintaining Decisions 19.51 and 19.53 in order to allow the implementation of this work in the upcoming intersessional period, and revising Decision 19.52 as contained in Annex 4 to the present document so that the final version of the action plan may be submitted for approval by the Conference of the Parties at its 21st meeting.

## Recommendations

- 9. The Standing Committee is invited to:
  - a) review the revised outline contained in Annex 2 to the present document for the finalization of the outline;
     and
  - b) propose to the Conference of the Parties at its 20th meeting to maintain Decisions 19.51 and 19.53, and revise Decision 19.52 as contained in Annex 4 to the present document.

The Resolution encourages Contracting Parties to be gender-responsive in the implementation of the Convention, recognizing the role of women, including Indigenous and local women, in the provision, management and safeguarding of wetlands. Guidance on Mainstreaming Gender Under the Ramsar Convention on Wetlands UN Convention to The UNCCD Gender Action Plan places gender equality firmly at the core of its mandate as a vital catalyst of environmental progress. Combat Desertification (UNCCD) UNCCD has undertaken an analytical study to establish a baseline for monitoring gender parity across the Convention in UNCCD subsidiary bodies and institutions: Committee on Science and Technology, Science Policy Interface, Bureau of the Committee for the Review of the Implementation of the Convention (CRIC). Bureau of the Conference of the Parties (COP), UNCCD Secretariat staff, and national delegations to CRIC and COP. The study provides a snapshot of the gender parity situation in each of these bodies, as well a recommendations tailored for each, on how to achieve a better gender balance. The At the 25th meeting of the Conference of the Parties (COP 25), Parties agreed **UN Framework** 

Convention on Climate Change (UNFCCC) The At the 25th meeting of the Conference of the Parties (COP 25), Parties agreed a 5-year enhanced Lima work programme on gender and its gender action plan (<u>Decision 3/CP.25</u>). At the 26th meeting of the Conference of the Parties (COP 26) Parties adopted the <u>Decision 20/CP.26</u>. The Decision includes, among other, aspects of the review of the Gender Action Plan implementation. The review of the implementation of the gender action plan is currently underway, with the final review to be concluded at the sixty-first session of the Subsidiary Body for Implementation in November 2024 (Decision 15/CP.28).
