OVERVIEW OF SPECIES UNDER REVIEW

1. This document has been prepared by the Secretariat.
2. In Resolution Conf. 14.8 (Rev. CoP16) on *Periodic review of species included in Appendices I and II*, the Conference of the Parties agrees on a process and guidelines for the Animals and Plants Committees to undertake a periodic review of animal or plant species included in the CITES Appendices and:

DIRECTS the Secretariat to maintain a record of species selected for periodic review, including: species previously and currently reviewed, dates of relevant Committee documents, recommendations from the reviews, and any reports and associated documents.

3. At its 27th meeting (AC27; Veracruz, April-May 2014), the Animals Committee reviewed document [AC27 Doc. 24.1](#), presenting an overview of species under review. The updated overview presented in this document follows the same outline and information fields.
4. At AC27, the Animals Committee agreed *inter alia* on the following actions [see document [AC27 WG8 Doc. 1](#) (Rev.1)]:

Regarding the [11] species selected for review between CoP15 and CoP17 for which reviews are ongoing but for which a reviewer is required, [...] the Animals Committee recommends that the relevant Regional Representatives and the Secretariat should write a letter to the relevant range States with the following points:

- *explain that the experience of the Animals Committee has shown that having range States lead or be engaged from the onset with a periodic review provides the best results;*
- *ask the range State to identify any barriers to them conducting a review, which could include things such as capacity or lack of experts;*
- *request comment on whether the range State agrees such a review is required or if the range State would object to removing the species from the periodic review; and*
- *ask whether the range State would have concerns if another Party or organization undertook the review, and whether they would be prepared to assist.*

5. In accordance with the recommendations made at AC27, the Secretariat sent letters on 13 May 2015 to the 22 range States concerned by the 11 species that remain to be reviewed between CoP15 and CoP17.

The following table provides the range State / Species combinations¹, and a summary of the replies received.

At AC27, the Committee concluded that should no volunteers be found to undertake the remaining reviews of the 11 species, the Animals Committee will need to be prepared to make a determination on retaining these species and seeking non-range State reviewers to undertake the review, or removing the species from the review at its 28th meeting.
7. The record of animal species selected for review between the 13th and 15th meetings of the Conference of the Parties (CoP13, Bangkok, 2004 and CoP15, Doha, 2010) is shown in Annex 1. The updated record of animal species to be reviewed between CoP15 and the 17th meeting of the Conference of the Parties (CoP17, 2016) is shown in Annex 2.
8. The species that were selected at AC27 for review between CoP16 and the 18th meeting of the Conference of the Parties (CoP18, 2019) are shown in Annex 3.
9. A list with abbreviations, and the ISO country codes used are contained in Annexes 4 and 5.

Recommendations

10. The Animals Committee is invited to take note of this document.
11. The Animals Committee is invited to consider the replies of the range States of the 11 species selected for review between CoP15 and CoP17, as indicated in paragraph 5, and decide on retaining or removing species for which no range State proposed to review.
