OVERVIEW OF SPECIES UNDER PERIODIC REVIEW

1. This document has been prepared by the Secretariat.
2. In Resolution Conf. 14.8 (Rev. CoP17) on *Periodic review of species included in Appendices I and II*, the Conference of the Parties agrees on a process and guidelines for the Animals and Plants Committees to undertake a periodic review of animal or plant species included in the CITES Appendices and in paragraph 6:
 6. *DIRECTS the Secretariat to maintain a record of species selected for periodic review, including: species previously and currently reviewed, dates of relevant Committee documents, recommendations from the reviews, and any reports and associated documents.*
3. Annex 1 shows the record of animal species selected for review between the 13th and 15th meetings of the Conference of the Parties (CoP13, Bangkok, 2004 and CoP15, Doha, 2010). The last page of this Annex contains a graphic representation of the origin of the species proposals submitted to CoP16.
4. The record of animal species to be reviewed between CoP15 and the 17th meeting of the Conference of the Parties (CoP17, Johannesburg, 2016) is shown in Annex 2. The last page of this Annex contains a graphic representation of the origin of the species proposals submitted to CoP17.
5. The animal species selected by the Animals Committee for review between CoP16 and the 18th meeting of the Conference of the Parties (CoP18, 2019) are shown in Annex 3.
 - a) Through Decisions 16.124, 16.125 and 13.93 (Rev. CoP16), the Animals Committee was directed to include *Cuora galbinifrons*, *Mauremys annamensis*, *Chelodina mccordi* and *Felidae* spp. in its Periodic Review of the Appendices following CoP16 (see documents [AC27 Doc. 24.3.1](#) and [AC27 Doc. 24.3.2](#)).
 - b) At its 28th meeting (AC28; Tel Aviv, August 2015), the Animals Committee reviewed document [AC28 Doc. 20.1 \(Rev.1\)](#). It agreed *inter alia* on the following actions (see document [AC28 Summary record](#)):

The Committee [...] agreed to remove from the Periodic Review those species, which were selected for review between CoP15 and CoP17 and for which no range States had volunteered to undertake the review.

*The Committee further welcomed Bhutan's expression of interest in reviewing *Semnopithecus schistaceus* and *Varanus bengalensis*, but noting its request for financial support for undertaking this review and the lack thereof, agreed to remove both species from the Periodic Review.*
6. A summary of all ongoing cases as of May 2017 is presented in Annex 4.

7. The records of species selected for Periodic Review, as presented in Annexes 1 to 3, follow the same form and format as previous submissions by the Secretariat. However, it is not clear if data fields containing information that may modify over time (conservation status; distribution) need to be kept up to date, and the Secretariat would appreciate guidance in this regard. Furthermore, in its comments on document [CoP17 Doc. 82.1](#), the Secretariat indicated that maintaining the records for the Periodic Review was increasingly demanding. It would be preferable to develop a searchable and manageable online Periodic Review database. The Secretariat has attempted to produce crude graphical representations of the data in Annexes 1 and 2, but this could be greatly enhanced with such an improved database. The Secretariat has no core-funding for these activities, and external funding would need to be secured for establishing and maintaining a Periodic Review database. The costs could be in the order of USD 50,000 for the period between CoP17 and CoP18.
8. A list of abbreviations and the ISO country codes used are contained in Annexes 5 and 6 respectively.

 - a. comment on the Secretariats' observations in paragraph 7; and
 - b. take note of this document.




