#### Preventing Human-Wildlife Conflicts to Conserve Endangered Wildlife

In addition to poaching and illegal trade, many endangered species world-wide are greatly threatened by human-wildlife conflicts (HWC). When wild animals harm livelihoods or threaten human lives, too often people feel helpless and simply set out to kill the animals. In poorly managed responses to HWC (such as illicit poisoning, trapping or shooting of endangered wildlife), both sides come out as losers; humans continue to suffer the harm and the damage, and in the end the wildlife get killed anyway. Dr. Nemtzov will explain about how to build an effective long-term strategic plan that can produce a real lasting solution to HWC. He will show effective non-lethal methods, as well as effective solutions based on modern hi-tech equipment, and also simple, cheap and effective "lo-tech" methods.
