ADMISSION OF OBSERVERS

1. This document has been prepared by the Secretariat.
2. In accordance with Rule 6, paragraph 2, of the Rules of Procedure of the Standing Committee, any body or agency technically qualified in protection, conservation or management of wild fauna and flora wishing to be represented at a meeting of the Committee by observers shall submit a request to the Secretariat at least 30 days before the meeting.
3. After having received from these organizations the relevant information concerning their technical qualifications or the approval of the State in which they are located, the Secretariat sent these requests to the Chair of the Standing Committee. No objection was received to the participation of the organizations that had requested to participate.
4. In consequence, the Secretariat, on behalf of the Chair of the Standing Committee, sent to the organizations listed in the Annex to the present document an invitation to attend the 66th meeting.
5. The above procedure does not apply to observers representing States not party to the Convention, nor to the United Nations, its Specialized Agencies or the International Atomic Energy Agency, which are entitled to be represented at meetings of the Standing Committee in accordance with Rule 5 of the Rules of Procedure.
