ADMISSION OF OBSERVERS

1. This document has been prepared by the Secretariat.
2. In accordance with Rule 4, paragraph 2, of the Rules of Procedure of the Standing Committee, any body or agency technically qualified in protection, conservation or management of wild fauna and flora wishing to be represented at a meeting of the Committee by observers shall submit a request to the Secretariat at least 30 days before the meeting.
3. The above procedure does not apply to observers representing States not party to the Convention, nor to the United Nations, its Specialized Agencies or the International Atomic Energy Agency, which are entitled to be represented at meetings of the Standing Committee in accordance with Rule 3 of the Rules of Procedure.
4. The list of observers that have submitted a request to the Secretariat at least 30 days before the meeting to attend the 74th meeting of the Standing Committee in accordance to Rules 3 and 4 of the Rules of Procedure can be found below.
