ADMISSION OF OBSERVERS

Bodies and Agencies Applying for Observer Status

1. According to Article XI, paragraph 7, of the Convention, any body or agency technically qualified in protection, conservation or management of wild fauna and flora, in the following categories, which has informed the Secretariat of its desire to be represented at meetings of the Conference by observers, shall be admitted unless at least one-third of the Parties present object:
  - a) international agencies or bodies, either governmental or non-governmental, and national governmental agencies and bodies; and
  - b) national non-governmental agencies or bodies which have been approved for this purpose by the state in which they are located.
2. Rule 2, paragraph 3, of the Rules of Procedure (Doc. 6.3) requires that bodies and agencies desiring to be represented at the meeting by observers shall submit the name of these observers (and, in the case of bodies and agencies referred to in paragraph (2) (b) of this Rule, evidence of the approval of the state in which they are located) to the Secretariat of the Convention at least one month prior to the opening of the meeting.
3. These provisions apply to all agencies or bodies other than the United Nations and its Specialized Agencies (which are not subject to the admission procedure of paragraph 7, according to Article XI, paragraph 6, of the Convention, and Rule 2, paragraph 1, of the Rules of Procedure).
4. Listed in the Annex of the present document are all bodies and agencies which as of 12 June 1987 had informed the Secretariat of their desire to be represented at the meeting by observers and which, in the case of national non-governmental agencies or bodies only, had been approved for this purpose by the state in which they are located. The Annex includes also an additional list of bodies and agencies which informed the Secretariat after 12 June 1987.
5. The lists are submitted to the meeting, for purposes of admission in accordance with Article XI, paragraph 7, of the Convention.
