AMENDMENT TO PROPOSAL COP14 PROP. 6

1. The attached document has been submitted by Kenya and Mali.
2. The geographical designations employed in this document do not imply the expression of any opinion whatsoever on the part of the CITES Secretariat concerning the legal status of any country, territory, or area, or concerning the delimitation of its frontiers or boundaries.

## Amendment to CoP14 Prop. 6

Submitted by Kenya and Mali.

The following replaces section A of CoP14 Prop. 6 (Doc. 68 Annex 2):

### A. Proposal

1. Amendment of the annotation regarding the populations of *Loxodonta africana* of Botswana, Namibia and South Africa to:

- include the following provision:

“Following the conditional sale of registered government-owned ivory stocks agreed at the 12<sup>th</sup> meeting of the Conference of the Parties, no trade in raw ivory shall be permitted for a period of 12 years except for raw ivory exported as hunting trophies for non-commercial purposes.”;

- amend the provision concerning ekipas as follows:

“6) trade in individually marked and certified ekipas incorporated in finished jewellery for non-commercial purposes for Namibia, subject to verification by the Secretariat, to be considered by the Standing Committee at its 57<sup>th</sup> meeting, that Namibia has sufficient national legislation and trade controls to ensure that the trade in ekipas is in compliance with the provisions of this annotation and managed in accordance with Resolution Conf. 10.10 (Rev. CoP12) and the *Action Plan for the Control of Trade in Elephant Ivory* as revised at CoP14.”

2. Amendment of the annotation regarding the population of *Loxodonta africana* of Zimbabwe to read:

“For the exclusive purpose of allowing:

- 1) export of hunting trophies for non-commercial purposes;
- 2) export of live animals for *in situ* conservation programmes;
- 2) export of hides;
- 3) export of leather goods for non-commercial purposes;
- 4) export of ivory carvings for non-commercial purposes, subject to on-going verification by the Secretariat, in consultation with the Standing Committee, that such trade is managed in accordance with Resolution Conf. 10.10 (Rev. CoP12) and the *Action Plan for the Control of Trade in Elephant Ivory* as revised at CoP14;

All other specimens shall be deemed to be specimens of species included in Appendix I and the trade in them shall be regulated accordingly.

No trade in raw ivory shall be permitted for a period of 12 years following the conditional sale of registered government-owned ivory stocks agreed at the 12<sup>th</sup> meeting of the Conference of the Parties except for raw ivory exported as hunting trophies for non-commercial purposes.”
