INFORMATION NOTE

Second global meeting of the wildlife enforcement networks, 28-29 September, Johannesburg, South Africa.

BACKGROUND

The Secretariat of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES), on behalf of the International Consortium on Combating Wildlife Crime (ICCWC), and with generous funding support from the Department of State of the United States of America will convene the Second Global Meeting of Wildlife Enforcement Networks (WENs) alongside the 17th meeting of the Conference of the Parties (CoP17) to CITES in Johannesburg, South Africa, in September 2016.

This meeting follows the 'First Global Meeting of Wildlife Enforcement Networks' hosted in Bangkok, Thailand, in 2013. It will promote the sharing of information on best practices and lessons learned about the establishment and functioning of WENs, further strengthen networks and enhance cooperation and coordination among them.

The meeting will bring together network representatives, wildlife law enforcement officers, and international organizations and other relevant organizations from around the world. The aim is to share experiences and consider measures to further strengthen WENs, promote their operational effectiveness, and enhance cooperation and interaction amongst them. The meeting will also consider the feasibility of developing best practice guidelines for the establishment of new WENs, as well as considering the development of targeted operational activities at the regional or global level. A draft agenda can be found below. A detailed agenda will be sent to registered participants in due course.

TARGET PARTICIPANTS

WENs or any similar regional or sub-regional structures with a primary function of facilitating cooperative activities amongst States to combat wildlife crime, are warmly invited to attend this meeting. In doing so, WENs are requested to nominate representatives from national customs, police or wildlife authorities from any countries served by the network to attend the meeting together with the network representative. Delegations should be limited to a maximum of three representatives per network and identify a head of delegation who is mandated to speak on behalf of the network.

TRAVEL, ACCOMMODATION AND LOCAL TRANSPORTATION ARRANGEMENTS

PREPARATORY WORK AND GUIDELINES FOR PRESENTATIONS

Network representatives will be contacted directly and requested to complete an information sheet with details on their respective networks. These information sheets will be provided to all meeting participants as background documents on the different networks, during the meeting.

Network representatives will be requested to prepare a short presentation (10-15 minutes) or an oral contribution to the meeting and to actively participate in the working groups. Details of the individual contributions will be discussed directly with the nominated participants on a case by case basis.

Observers are invited to participate in the meeting and will be able to contribute to the meeting during the Q&A sessions. Participation of observers in working group discussions will be at the discretion of the chair of the different working groups.

LANGUAGE AND INTERPRETATION

The meeting will be held in English. Interpretation will however be available in French and Spanish for all plenary sessions. Interpretation is not available for the working group discussions. To promote active participation in the working group discussions, networks are therefore encouraged to nominate representatives for these sessions that are able to communicate in English.

Any documents or reports from the meeting will be prepared in English and translated in due course into French and Spanish.

The meeting will be held on 28 and 29 September 2016 at the Sandton Convention Center in Johannesburg, South Africa. The daily work programme will start at 9 a.m. and end at 6 p.m.
