VUE D'ENSEMBLE DES ESPECES SELECTIONNEES

1. Le présent document a été préparé par le Secrétariat.
2. Dans la résolution Conf. 14.8 (Rev. CoP16), *Examen périodique des espèces inscrites aux Annexes I et II*, la Conférence des Parties décide d'un processus et de lignes directrices selon lesquels le Comité pour les animaux et le Comité pour les plantes entreprennent l'examen périodique des espèces animales et végétales inscrites aux annexes CITES, et:

DONNE INSTRUCTION au Secrétariat de tenir un registre des espèces sélectionnées pour un examen périodique, y compris des espèces ayant fait l'objet ou faisant actuellement l'objet d'un examen, dates des documents pertinents du comité, recommandations des examens, et tout rapport et documents liés.

3. À sa 27^e session (AC27; Veracruz, avril-mai 2014), le Comité pour les animaux a examiné le document AC27 Doc. 24.1 présentant un aperçu des espèces à examiner. La synthèse actualisée du présent document suit le même schéma et touche aux mêmes domaines d'information.
4. À l'AC27, le Comité pour les animaux a convenu, entre autres, de conduire les actions suivantes [voir le document AC27 WG8 Doc. 1 (Rev.1)]

Concernant les [11] espèces sélectionnées pour l'examen périodique entre la CoP15 et la CoP17 dont l'examen est en cours mais pour lesquelles il n'y a pas de responsable de l'examen, [...] le Comité pour les animaux recommande que les représentants régionaux compétents et le Secrétariat écrivent une lettre aux États de l'aire de répartition concernés en tenant compte des points suivants:

- *expliquer que l'expérience du Comité pour les animaux a prouvé que lorsque les États de l'aire de répartition dirigent un examen périodique ou y participent dès le début, les résultats sont meilleurs;*
- *demander à l'État de l'aire de répartition de déterminer tous les obstacles qui l'empêchent de conduire cet examen et qui pourraient comprendre, par exemple, la capacité ou l'absence de spécialistes;*
- *demander à l'État de l'aire de répartition de commenter la nécessité de conduire un tel examen, ou s'il est opposé à la suppression de l'espèce de l'examen périodique; et*

- demander à l'État de l'aire de répartition s'il verrait un inconvénient à ce qu'une autre Partie ou une organisation conduise l'examen, et s'il serait prêt à lui accorder son appui.

5. Conformément aux recommandations formulées à l'AC247, le Secrétariat a adressé des courriers le 13 mai 2015 aux 22 États de l'aire de répartition concernés par les 11 espèces qui restent à examiner entre la CoP15 et la CoP17. Le tableau ci-dessous présente les diverses combinaisons États de l'aire de répartition / espèces¹, avec un résumé des réponses reçues.
