NOTIFICATION TO THE PARTIES

CONCERNING:

Entry into force of the amendment to Article XXI of the text of the Convention (Gaborone, 30 April 1983)

- 1. On 30 April 1983, the Conference of the Parties adopted an amendment to Article XXI of the Convention, at an extraordinary meeting held in Gaborone, Botswana. This amendment provides the possibility for regional economic integration organizations to accede to the Convention and its text is provided in Annex 1 to this Notification.
- 2. On 30 September 2013, Costa Rica deposited with the Swiss Confederation an instrument of acceptance of the 'Gaborone amendment'. Thus, 54 of the 80 States that were party to CITES on 30 April 1983 (i.e. two-thirds of them) have now deposited their instruments of acceptance of this amendment. Consequently, in accordance with Article XVII, paragraph 3, of the text of the Convention, the amendment shall enter into force on 29 November 2013 for these 54 States, as well as for the 43 States that became party to CITES after 30 April 1983 and that have already accepted the amendment (see Annex 2). For any State that becomes a Party after 29 November 2013, the amended text of the Convention will apply automatically.
- 3. However, for States that became party to the Convention before that date and have not accepted the amendment, it will enter into force 60 days after they accept it. Twenty-six States party to the Convention on 30 April 1983 and 55 States that became party to CITES after that date have not accepted the Gaborone amendment (see Annex 3). The Secretariat urges these Parties to accept the Gaborone amendment and, if relevant, the Bonn amendment (adopted on 22 June 1979 and in force since 13 April 1987) as soon as possible by depositing an instrument of acceptance with the Depositary Government, the Government of the Swiss Confederation.
- 4. This Notification replaces Notification to the Parties No. 2010/039 of 1 December 2010.

Annex 1

Gaborone amendment to the text of the Convention

The Gaborone amendment consists of inserting five new paragraphs after the words "Depositary Government." in Article XXI of the Convention, as follows:

- 1. The present Convention shall be open indefinitely for accession. Instruments of accession shall be deposited with the Depositary Government.
- 2. This Convention shall be open for accession by regional economic integration organizations constituted by sovereign States which have competence in respect of the negotiation, conclusion and implementation of international agreements in matters transferred to them by their Member States and covered by this Convention.
- 3. In their instruments of accession, such organization shall declare the extent of their competence with respect to the matters governed by the Convention. These organizations shall also inform the Depositary Government of any substantial modification in the extent of their competence. Notifications by regional economic integration organizations concerning their competence with respect to matters governed by this Convention and modifications thereto shall be distributed to the Parties by the Depositary Government.
- 4. In matters within their competence, such regional economic integration organizations shall exercise the rights and fulfil the obligations which this Convention attributes to their Member States, which are Parties to the Convention. In such cases the Member States of the organizations shall not be entitled to exercise such rights individually.
- 5. In the fields of their competence, regional economic integration organizations shall exercise their right to vote with a number of votes equal to the number of their Member States which are Parties to the Convention. Such organizations shall not exercise their right to vote if their Member States exercise theirs, and vice versa.
- 6. Any reference to "Party" in the sense used in Article I (h) of this Convention, to "State"/"States" or to "State Party"/"State Parties" to the Convention shall be construed as including a reference to any regional economic integration organization having competence in respect of the negotiation, conclusion and application of international agreements in matters covered by this Convention.
