CONCERNING:

QUESTIONNAIRE ON THE IMPLEMENTATION OF RESOLUTION CONF. 16.5

- 1. This document has been submitted by the Acting Chair of the Plants Committee.
- 2. At its 21st meeting (2014), the Plants Committee established an intersessional working group on the implementation of Resolution Conf. 16.5 on *Cooperation with the Global Strategy for Plant Conservation of the Convention on Biological Diversity*. As part of the work, the GSPC Working Group developed a questionnaire to obtain information from Parties on implementation of the Resolution.
- 3. The questionnaire was first distributed in July 2015 to CITES Management and Scientific Authorities by Mr. Hesiquio Benítez (Mexico) as chair of the Plants Committee Working Group. Thirty four Parties responded to the questionnaire in time for the 22nd meeting of the Plants Committee (October 2015), including: Argentina, Austria, Brazil, Bulgaria, Chile, Colombia, Costa Rica, Cuba, Czech Republic, Denmark, Ecuador, Finland, Greece, Honduras, Italy, Jamaica, Mexico, Monaco, Montenegro, Montserrat, Netherlands, New Zealand, Norway, Panama, Peru, Portugal, Republic of Moldova, Seychelles, Slovakia, Spain, Switzerland, Turkey, United Kingdom of Great Britain and Northern Ireland (including Overseas Territories, UKOTs), and United States of America.
- 4. The Plants Committee discussed progress in implementation of Resolution Conf. 16.5 on Cooperation with the Global Strategy for Plant Conservation of the Convention on Biological Diversity at its 22nd meeting in October 2015, as part of its discussion on <u>PC22 Doc. 7.2 (Rev. 2)</u>. The Plants Committee encouraged Parties to complete the questionnaire.
- 5. The purpose of this Notification is to encourage Parties to complete the questionnaire on implementation of the Resolution if they have not done so already, or to amend their responses if there are updates. The questionnaire is provided as Annex to this Notification.
- 6. The responses received to this Notification will be incorporated by Mexico into a report on CITES contribution to the implementation of GSPC 2011-2020 (Res. Conf. 16.5). Mexico submitted a document to the 17th meeting of the Conference of the Parties (CoP17, Johannesburg 2016) which recommends the Conference of the Parties agree to submit the report to the Secretariat of the Convention on Biological Diversity in order for it to be considered at *CBDs 13th meeting of the Conference of the Parties* (COP13-CBD, Cancun, México; December 2016).
