Nineteenth meeting of the Conference of the Parties:
Important visa information and deadline

1. The Secretariat wishes to draw to the attention of the participants in the 19th meeting of the Conference of the Parties the detailed information about the visa application process in the Annex to this Notification.
2. Of particular importance is **the deadline of 1 September to apply for a visa**. Participants will obtain a visa assistance letter only after they have registered and sent a nomination letter. Additionally, participants from observer organizations also need to pay their registration fees before they can obtain a visa assistance letter.
3. The Secretariat therefore strongly encourages all Parties and observers to **register and send their nomination before 31 August 2022**.

⁵ Indonesian nationals with a diplomatic, consular or other official passport do not need a visa to enter Panama.

⁶ Filipino nationals with a diplomatic, consular or other official passport do not need a visa to enter Panama.

⁷ Korean nationals with a diplomatic, consular or other official passport do not need a visa to enter Panama.

⁸ Venezuelan nationals with a diplomatic, consular or other official passport do not need a visa to enter Panama.

Other possible visa exemptions:

All foreigners with nationalities that require a visa to enter Panama, but who have a valid visa or residence, duly issued by:

- Australia;
- Canada;
- any State of the European Union;
- Japan;
- Republic of Korea;
- Singapore;
- United Kingdom of Great Britain and Northern Ireland; or
- United States of America;

can enter Panama, as a tourist, without the need for an entry visa, **if the visa for these countries:**

- a) has been granted for multiple entries and exits;
- b) has been used at least once to enter the issuing country; and,
- c) is valid for at least six (6) months at the time of entering Panamanian territory.

Where to apply for a visa?

**ALL VISA APPLICATIONS SHOULD BE SUBMITTED
TO THE CLOSEST PANAMAIAN EMBASSY
BY 1 SEPTEMBER 2022.**

Countries that need a visa

AND

HAVE a Panamanian embassy or consulate in their country:

China; Cuba; Dominican Republic; Egypt; Haiti; India; Indonesia; Jordan; Morocco; Philippines; Republic of Korea; Venezuela (Bolivarian Republic of).

Please approach the embassy in your country as soon as possible with the visa support letter provided by the Secretariat. The Secretariat provides a visa support letter ONLY to delegates listed in the official nomination letters.

TOURIST VISA

ARTICLE 17

Requirements:

1. Completed visa application.
2. Original and a copy of all the pages of your passport or travel document, with at least three (3) months' validity.
3. Flight reservation with itinerary of trip continuation or electronic ticket.
4. Copy of a valid I.D. or resident card from the country of residence of the applicant.
5. Three (3) photographs; when the visa applications are submitted abroad, with the exception of tourist visa applications submitted to the National Immigration Service at the Republic of Panama.
6. Payment of a fee of fifty balboas (B/.50.00) for immigration services when presenting the application at the National Immigration Service.
7. Proof of economic solvency during the stay, which cannot be less than five hundred balboas (B/.500.00). This can be proven with one of the following documents:
 - 7.1. Certified bank cheque or money order in the name of the applicant.
 - 7.2. Traveller's cheques in the name of the applicant.
 - 7.3. Applicant's bank certification with bank statement from the last month showing the available balance.
 - 7.4. Applicant's credit card statements from the last month showing the available balance.
 - 7.5. Work certificate with latest pay cheque or independent worker accreditation, in case of being an employee of a private or public entity.
 - 7.6. If you are a retired citizen or a pensioner, submit certification of retirement or pension and proof of income received.
 - 7.7. If you are a freelancer, submit an income declaration from the last fiscal year.
 - 7.8. If acting as a businessman or businesswoman, submit a bank reference.

- 7.9. Letter of responsibility, certificate proving the family relations and proof of economic solvency for economically dependent persons.
- 7.10. Any other reasonable proof of income accepted by the National Immigration Service.
8. Latest visa approved by the Panamanian immigration authorities (if applicable).
9. Hotel reservation (if applicable)
10. Present, if applicable, a letter of invitation, which may come from:
 - 10.1. Temporary or permanent residents in Panama or Panamanian citizens, providing the following documents as applicable:
 - 10.1.1. Authentic copy of the national identification card of the Panamanian citizen.
 - 10.1.2. Copy of the passport and the I.D. card of the foreign citizen.
 - 10.1.3. Proof of payment for public services showing the home address of the responsible person.
 - 10.2. Private entities, providing the following:
 - 10.2.1. Certification from the Public Registry;
 - 10.2.2. Copy of the *Aviso de Operaciones* (commercial licence).
 - 10.2.3. Copy of the document approving operations in the Colon Free Trade Zone (if applicable).
 - 10.2.4. Proof of payment for public services showing the address of the responsible company.
11. If presenting a letter of invitation, the economic solvency of the inviter can be proven with any of these documents:
 - 11.1. Bank certification.
 - 11.2. Income tax declaration and certificate of good standing.
 - 11.3. Letter of employment with the latest social security statement (for natural persons).
