World Wildlife Day 2023: In-person World Wildlife Day event in Washington, D.C.

- 1. This notification is published by the Secretariat.
- 2. With reference to Notification to Parties No. 2022/085 (issued 20 December 2022), World Wildlife Day 2023, which will also mark the 50th anniversary of the signature of the Convention, will be celebrated around the world on 3 March under the theme "Partnerships for Wildlife Conservation". The theme focuses on all who are working for wildlife conservation and making a difference for wild species, ecosystems, people and livelihoods and for CITES.
- 3. This year, the Government of the United States of America and the CITES Secretariat will co-host the official in-person event of the World Wildlife Day on **Friday 3 March from 10:00 12:30 (EST)** at the National Geographic Grosvenor Auditorium (1600 M St NW, Washington, D.C. 20036, USA) in collaboration with other partners. The event will be in English only; the provisional agenda of the event is attached herewith for your information.
- 4. Parties are invited to contact their representations in Washington D.C. to participate in the event and forward the attached invitation letter (which will be required for registration). Interested Party representatives are requested to register their attendance through the link below:
