Registration

3. All participants must register in advance for this meeting. Registration for the meeting is now open and focal points of Parties and observers who attended the 19th meeting of the Conference of the Parties should have received an exclusive link for online registration by email. If you have not received an exclusive link, please contact the CITES Secretariat at registration@cites.org. Early registration is recommended for participants who require an entry visa to Switzerland.
4. The Secretariat reminds UN agencies and observer bodies or agencies technically qualified in protection, conservation or management of wild fauna and flora that, according to Rules 3 and 4 of the Rules of Procedure, they need to register by **6 May 2023** for PC26.
5. The Secretariat further reminds observer Parties that, according to Rule 2 of the Rules of Procedure, they need to register by **29 May 2023** for PC26.

Visas to Switzerland

6. The Secretariat reminds Parties and organizations that their representatives may require visas. A visa assistance letter will be sent automatically to all participants whose nomination has been validated. The Secretariat reminds Parties and organizations that such letters will be sent only after it has received an official nomination letter.
