Call for nomination of participants: Training workshop on sharks, rays, and sea cucumber identification

- 1. This Notification is published at the request of Singapore.
- 2. Singapore, Hong Kong SAR of China, Bloom Association (HK) and Wildlife Conservation Society (WCS) are jointly organizing an in-person training workshop on sharks, rays, and sea cucumber identification in Singapore, from 17 to 18 October 2023. All interested Parties are welcomed to participate in the workshop.

Objectives of the training workshop

- 3. This workshop is held in view of the recent listing of additional species of sharks, rays, and sea cucumbers on Appendix II at the 19th Meeting of the Conference of the Parties (CoP19, Panama City 2022) last year, some of which will soon enter into effect in November 2023.
- 4. The objectives of the workshop are to:
 - a) promote a better understanding of the trade in shark fins and sea cucumbers;
 - b) equip frontline officers with tools (e.g. <u>Fin Finder</u>) and skillsets to identify shark fins and sea cucumbers;
 - c) discuss trends and patterns of illegal trade in sharks, rays, and sea cucumbers; and
 - d) introduce reference materials and tools available to assist officers with rapid species assessment.
- 5. Detailed information about the program can be found in Annex A of this notification.

6. The meeting will be <u>in-person only</u>, without the possibility of online participation.

Participation of secondary nominations will be subject to the availability of space, which will be communicated at the next stage once primary nominations are confirmed.
- 9. Travel costs, accommodation and meals should be borne by your agency or respective governments.
- 10. All participants are responsible for checking visa requirements for Singapore and must complete the health declaration before arrival, cover the cost of their visas as well as obtain necessary medical and welfare insurance to cover the full duration of the meeting.
