CONCERNING:

CITES-WCO online Workshop on Risk Assessment and Inspections for CITES Trade Controls

1. The Secretariat hereby informs Parties that the CITES WCO Workshop on Risk Assessment and Inspections for CITES Trade Controls will be held online on 17 March 2025 from 1400-1600 Central European Time (CET).

Mandate

2. At its 19th meeting (CoP19; Panama City, 2022), the Conference of Parties adopted Decision 19.154 on *Risk assessment and analysis for border control*, and Decision 19.152, paragraph a), on *Electronic systems and information technology*, as follows:

Directed to the Secretariat

19.154 The Secretariat shall, subject to available resources, work with the World Customs Organization and other partners to develop guidance, including a specific guidance for a risk-based analysis related to the process of analysis and inspection under CITES permit issuing systems, and elements for a national policy on physical inspections and present its report and recommendations to the Standing Committee.

Directed to the Secretariat

- **19.152** The Secretariat shall, subject to the availability of external funding:
 - a) undertake a study on the information used by different Parties in a risk-based approach for CITES trade controls
- 3. As reported in document <u>SC78 Doc.52</u> at the 78th meeting of the Standing Committee, and pursuant to the above Decisions, the Secretariat, in collaboration with the World Customs Organization (WCO) and with funding from the European Union, initiated a study and developed a draft guidance on risk assessment and inspections for CITES trade controls.
- 4. The draft guidance is now available for review by the Parties and will be presented at the online workshop on 17 March for further discussion. In the meantime, interested Management Authorities willing to review the draft guidance are invited to send an email to
