## Amendment of procedures for export of wild animals in Sudan

1. This Notification is being published at the request of Sudan.
2. The CITES Management Authority of Sudan, Wildlife Conservation Authorities, wishes to inform CITES Parties on the amendment of its procedures for export of wild animals.
3. The CITES Management Authority of Sudan has amended its export procedures to ensure that the initial export permit, delivered to support requests for obtaining import permit, is not exploited for wildlife smuggling.
4. In accordance with the amended procedures, an initial export permit will be issued, containing the basic information related to the shipment. After obtaining written approval from the CITES Management Authority of the importing country, the final CITES certificate will be issued in the internationally known form and will include the export permit number in the field (operations number).
5. A sample of the initial export permit is attached to this Notification.
