Cours de maîtrise sur la gestion et la conservation des espèces  
faisant l'objet d'un commerce : le cadre international

1. Le Secrétariat a le plaisir de diffuser les informations ci-dessous, à la demande de l'Université internationale d'Andalousie (UNIA).
2. L'UNIA reprend l'organisation de la 14<sup>e</sup> édition de son cours de maîtrise, *Gestion et conservation des espèces faisant l'objet d'un commerce : le cadre international*. Cette 14<sup>e</sup> édition, qui avait été planifiée pour 2020, a été reportée en raison des restrictions liées à la pandémie de COVID-19, celles-ci ayant eu pour effet de rendre impossibles les cours en présentiel sur le campus.
3. Au cours des 13 éditions précédentes, 350 étudiants de 97 pays ont reçu une formation spécialisée sur la Convention sur le commerce international des espèces de faune et de flore sauvages menacées d'extinction (CITES) ainsi que sur les questions d'actualité en relation avec la conservation et l'utilisation durable de la biodiversité.

## Background

The International University of Andalusia (UNIA) has now held thirteen editions of this Master's programme. After thirteen editions, it has provided specialized, quality training to **350 students from 97 countries**.

## Objectives of the programme

**The general objective** of the programme is to provide high quality, specialized training on the scientific bases, techniques, and instruments that enable CITES implementation and development, in order to strengthen the fight against illegal trade, particularly in those countries of origin where animals and plants are subject to international trade.

**The specific objectives** are to provide specialized training on:

- The concept of biodiversity at all organizational levels, particularly at population, species, and ecosystem levels.
- Scientific bases and methodologies for identifying and solving problems that hinder proper implementation of CITES.
- Administrative, legislative and enforcement aspects of CITES implementation.
- Biological and trade-related criteria for listing species in CITES.
- Population survey techniques. Population biology, conservation, and management of CITES-listed fauna and flora. *In situ* and *ex situ* conservation methods.
- Application of geographic information systems and spatial data to the study of the current and potential distribution of species and assessment of habitat suitability.
- Wildlife recovery plans and sustainable management programmes.
- Analyses for making non-detriment findings for CITES-listed species.
- Analyses and procedures for the CITES Significant Trade Review.
- Techniques for identification and control of CITES-listed species and specimens.

## Admission into the programme

This Master's programme is appropriate for people who are involved or wish to become

involved in environment-related policy making, in the implementation of CITES and the development of the scientific and technical work required for its implementation at the executive level.

To be eligible for the Master's programme, candidates must hold a bachelor's degree (or an equivalent degree accredited by a university) in one of the following areas: engineering (agricultural, forestry, environmental); veterinary science; biological science; zoology; botany; environmental science; chemistry; geography and history; humanities; education sciences; law; policy and international relations. The academic record, the professional and scientific curriculum, and its relationship with the application of CITES are valued.

## Duration and academic structure

The Master's Degree consists of 60 ECTS\* (European Credit Transfer and Accumulation System) credits. The programme is structured as follows:

- A. On-campus period from 18<sup>th</sup> April to 1<sup>st</sup> July 2022 (presence required) related to the contents of eleven subjects (clustered into 3 sections). Subjects 3, 4 and 11 will be given in English and Spanish with simultaneous interpretation. If external funding is not available, the rest of the subjects will be given only in English.
- B. Research period (presence not required), in which students will perform research tasks in preparation for the final Master's Thesis.

**On-campus credits:** 44 ECTS credits will be taught at the Antonio Machado Site of the International University of Andalusia for 11 weeks from Monday to Friday, in morning and afternoon sessions. Monitoring and assessment will consist of weekly individual and/or group tests on the covered contents.

**Virtual period:** from 1<sup>st</sup> February to 25<sup>th</sup> July 2022. The UNIA Virtual Platform will provide further learning experience and various practical activities on the course content.

**Research period:** 16 ECTS credits will be given for supervised research activities leading to the presentation of a Master's Thesis. To

obtain the Master's Degree issued by the International University of Andalusia, participants must first pass the on-campus period and subsequently prepare and submit a Master's Thesis. The thesis must be completed and approved within the deadlines set by the University (1 October 2022-first call or 1 April 2023 final call). Students who fail to meet this requirement must register and pay again for the 16 research credits in the next edition of the Master's programme.
